The election will take place at the Retreat on Oct. 4.


Opportunities to lead or join issue and action committees will also be offered.

DISARM COMMITTEE AND S. RES. 323, CALLING FOR AN END TO THE NUCLEAR ARMS RACE

On July 16, 2025, Senator Markey (MA) introduced S. Res. 323, Current co-sponsors are Senators Merkley (OR), Peter Welch (VT), Sanders (VT) and Van Hollen (MD). The bill, which is subtitled "Urging the United States to lead a global effort to halt and reverse the nuclear arms race" was referred to the Committee on Foreign Relations.

It's an excellent resolution:

"RESOLVED: That the Senate calls on the President to:

(1) actively pursue a world free of nuclear weapons as a national security imperative; and

(2) lead a global effort to halt and reverse a global nuclear arms race and prevent nuclear war, by engaging in good faith negotiations with the other 8 nuclear armed countries to halt any further buildup of nuclear arsenals; and aggressively pursue a verifiable and irreversible agreement or agreements to verifiably reduce and eliminate their nuclear arsenals according to negotiated timetables,

Leading the effort to have all nuclear-armed countries renounce the option of using nuclear weapons first;

Implementing effective checks and balances on the sole authority of the President, as Commander-in-Chief, to order the use of UnitedStates nuclear weapons;"...and a number of other common-sense measures that would improve the safety, security, health and economic well-being of everyone.

DISARM Committee Chair WILPF Fresno/Back from the Brink representative Carol Goiburn will visit the offices of Senators Padilla and Schiff and ask them to take the first step of meeting online with Dr. Ira Hefland and other Back from the Brink representatives. The hope is that the senators from California will be convinced of the moral and political need to co-sponsor S. Res 323. Check this space next month for updates. INTERNATIONAL EFFORT TO END GENOCIDE AND OCCUPATION IN PALESTINE

"Together, we have begun the work of ending the era of impunity. These measures show that we will no longer allow international law to be treated as optional, or Palestinian life as disposable."

On July 15, 2025, representatives from more than 30 countries met in Bogotá to work on stopping the Israeli genocide in Palestine. Discussion included sanctions, severance of diplomatic relations and other measures. Action followed.

"The Bogotá conference will go down as the moment in history that states finally stood up to do the right thing," said Francesca Albanese, the Italian legal scholar and expert on human rights who serves as UN Special Rapporteur on the occupied Palestinian territories.

Twelve nations—Bolivia, Colombia, Cuba, Indonesia, Iraq, Libya, Malaysia, Namibia, Nicaragua, Oman, Saint Vincent and the Grenadines, and South Africa—have agreed to implement six measures immediately, and they are calling on others to join by Sept. 20, 2025, the 80th UN General Assembly meeting.

The six measures are as follows:

- 1. Prevent the provision or transfer of arms, munitions, military fuel, related military equipment, and dual-use items to Israel.
- 2. Prevent the transit, docking, and servicing of vessels at any port...in all cases where there is a clear risk of the vessel being used to carry arms, munitions, military fuel, related military equipment, and dual-use items to Israel.
- Prevent the carriage of arms, munitions, military fuel, related military equipment, and dual-use items to Israel on vessels bearing our flag...and ensure full accountability, including de-flagging, for non-compliance with this prohibition.
- 4. Commence an urgent review of all public contracts, to prevent public institutions and funds from supporting Israel's illegal occupation of the Palestinian Territory and entrenching its unlawful presence.
- 5. Comply with obligations to ensure accountability for the most serious crimes under international law, through robust, impartial and independent investigations and prosecutions at national or international levels, to ensure justice for all victims and the prevention of future crimes.
- 6. Support universal jurisdiction mandates, as and where applicable in national legal frameworks and judiciaries, to ensure justice for victims of international crimes committed in the Occupied Palestinian Territory.
