The general election on Tuesday, November 4 is a pivotal time when Fresno and the nation will decide whether or not we have had enough of the Republican Party, with their endless wars, the collapse of the economy, and violations of our civil liberties.

In this issue you will find several articles about the upcoming elections, a progressive voting guide on page 5, and my favorite - comments from readers and subscribers about who they are going to vote for in the presidential election (starting on page 7). Nobody, who wrote to the Community Alliance about the elections, suggested that voters Henry T. Perea, on the other hand, is a Democrat, he should even consider McCain/Palin.

My opinion is that the presidential election November 4 will result in either Obama or McCain being elected. There is not a snowballs chance in hell that a third party candidate will be elected as president. The choice is between Obama and McCain and who progressives should vote for seems obvious.

lum back in the direction of more social programs and a safety net. If Obama wins, and I think he will, his success in moving this country to the left will depend on our ability to build a powerful grassroots movement that will hold him accountable to those of us who get him elected.

I see a strong connection between the national trend to repudiate the politics of the Republican Party and the local mayoral race in Fresno. The pro-Democratic tidal wave that elects Obama and produces an increased Democratic majority in Congress will have an effect here locally. Henry T. Perea, the Democrat in the race for mayor, will win the election because voters in Fresno want changes that the Republicans will not and can't implement. Under Republican rule, Fresno now has the highest concentration of poverty in the country, we needed a Federal Judge to stop the city from attacking the homeless, we have some of the worst air quality, an unacceptable high school drop out rate (over 50% of my daughter's classmates dropped out before graduating at Fresno High), and our best and brightest are leaving for better opportunities elsewhere. The Republicans are close to destroying the nation and our city. It is time for a change!

Ashley Swearengin says that she will bring us "Fresh Leadership" and "Real Change for Fresno." Swearengin presents herself as the "outsider" who will shake up City Hall and bring about change. I'm hoping Community Alliance readers and subscribers will not be fooled by her campaign. Swearengin is a conservative Republican (Fresno has been ruled by Republicans for the last 15 years) who would continue the policies and practices of her predecessors. She is as different from Autry as McCain is to George Bush. See the article on page 3 and ask yourself if you share her values - Swearengin is anti-choice (she is against women's reproductive rights), opposes marriage equality (she supports proposition 8), supports John McCain for president, and says ingly, the debate in this newspaper is between whether she has a lot in common with Sarah Palin. # **Letter to the Editor**

I want to thank author Vic Bedoian and the Community Alliance for publishing "Power Hungry," the best news story I've read so far on PG&E's plans to build a huge 500 kilovolt transmission project through the Sierra foothills of Kern, Tulare, and Fresno counties.

This project is yet one more example of how "our" government which purports to be "of the people, by the people, and for the people" is really a government "of the profit, by the profit, and for the profit" and is run now, as it has always been, by the elite investor class, the one percent of the population that controls nearly 50 percent of the wealth.

Fighting this project for the past year, I have developed a special appreciation for the Native Americans whose land was stolen by "our" government at the behest of the profiteers in the nineteenth century. Our plight pales in comparison to that of the local Yokuts and Mono who were finagled out of their land in the San Joaquin Valley and Sierra in the 1850s. But the people of the foothills are being treated in a similar manner now that PG&E and other powerful corporations see that they can use our land to increase their profits.

This plan — the so-called Central California Clean Energy Transmission Project (C3ETP) — purports to be about meeting our needs for clean energy. However, it is at least as much about profit and destruction of the environment and of ordinary people as it is about clean energy. It is the same old story we have heard so many times over the last many years of deregulation and privatization. The government, such as it is, will hardly be involved in this project.

Indeed, as you read, the California Public Utilities Commission is planning to farm out more of its responsibilities to the private sector — meaning huge corporations — so that they can look out for you and me. Fat chance of the fox looking out for the chickens' needs! Besides, the CPUC is made up mostly of appointed industry partisans who have little interest in looking after ordinary people.

No, while all the new plans like C3ETP are green-washed to look like efforts to integrate clean energy into the grid,

# **Ashley Swearengin and** Transparency

Ashley Swearengin wants to be the next mayor of Fresno. She has spoken openly and articulately about local issues. She has also discussed issues of statewide importance. In a meeting with the Central Valley Progressive PAC, Swearengin said, during a discussion about proposition 8 (regarding marriage equality) that because she was a candidate "people have a right to know anything and everything about you." The Community Alliance, following the old saying "Think Globally, Act Locally" decided to ask Swearengin about her positions on a wide variety of issues.

For example, where does she stand on the war and occupation of Iraq? To our surprise, she refused to answer. Does Swearengin think giving money to war profiteers, mercenaries, shipping pallets of \$100 bills to Iraq (which were never accounted for), and occupying Iraq is a better use of money than providing health care for the tax payers of Fresno, fixing roads, or improving education? Would Swearengin support a City Council resolution to end the war and occupation? Don't ask her, she will not answer the question.

The Community Alliance asked Swearengin if she supports reproductive rights for women. Again, she refused to answer. Her campaign manager, David well known and have been heard at numerous forums MikeRhodes@Comcast.net

Schecter, said that he would refuse to confirm or deny  $\,$  and debates. For their answers to questions about lo-  $\omega$ any positions his candidate holds which we independently discovered. We found, on the issue of reproductive rights for women that Swearengin is anti-choice.

Billie MacDougall, the past President (2004 - 2005) of the National Women's Political Caucus, said that her group "did not know that Swearengin was anti-choice when we invited her to speak on the Regional Jobs Initiative. When we heard that she was contemplating running for mayor we asked if she wished to apply for endorsement by the NWPC. Her reply was that she could not apply because she is not pro-choice."

Swearengin's response to questions about marriage equality became an issue when she first opposed and then supported proposition 8. The Lesbian, Gay, Bi, Transgender, questioning (LGBTQ) community have been critical of her flip/flop on this issue. But, Swearengin's position on this issue is consistent with her core values and base of support - she is opposed to equal rights for the LGBTQ community.

We asked: "Do you Support Obama or McCain for president?" Swearengin refused to answer. Swearengin, a Republican, is supporting John McCain for president. We know this because Swearengin said, at a debate at the Tower Theater, that she supports McCain and that "I'm also looking forward to meeting Governor Palin. I ### think we have a few things in common."

cal issues of concern to the progressive community, go to: www.cvppac.org . Swearengin's refusal to answer questions says a lot about her transparency and what the progressive community might expect if she is elected. We know that she is a conservative Republican, she supports John McCain for president, is antichoice, and is against marriage equality. She refuses to tell us if she supports the ongoing war and occupation of Iraq. She doesn't want us to know if she supports torturing prisoners, if she wants City of Fresno employees to earn a living wage, or whether or not the US ployees to earn a living wage, or whether or not the US should invade Iran. So much for transparency!

Where does mayoral candidate Henry T. Perea stand on these issues? Perea proudly supports Barack Obama for president, he supports marriage equality (he is against proposition 8), he is not afraid to say that he is against torturing prisoners, is pro-choice, and does not want to see the US invade Iran.

Fresno progressives have a choice to make on Tuesday, November 4. They can vote for 4 more years of right wing, conservative, Republican rule - both locally and nationally OR they can vote for a change. Henry T. Perea and Barack Obama represent HOPE and CHANGE for a better world.


# Fresno Police Intimidate Democratic Party Volunteers

According to volunteers at the Democratic Party booth at the BIG Fresno District Fair, two uniformed Fresno Police Department (FPD) officers told them that the brochures they had on their table for Henry T. Perea (candidate for mayor, who is a Democrat) were illegal. The officers complained that the brochure contained a photo of FPD Chief Jerry Dyer standing with Perea. The volunteer, upon being told by the officers that the brochures were illegal, removed them from the table.

The controversy over the brochure first emerged shortly after Perea supporters started distributing the brochures in NE Fresno. An October 1 story on KFSN -TV had political analyst Tony Capozzi saying, "Clearly he's been endorsed by the Fresno Police Officers' Association and various other law enforcement agencies but right next to that is a picture of the candidate Henry Perea with the Chief." Capozzi said, "What's really, what I'm thinking, improper is a picture with the chief with his uniform on, with his badge on. That's illegal if the chief knew this was going on." Not mentioned on the KFSN report or by Capozzi was that Fresno City Council member Jerry Duncan, in his campaign for mayor during the primary election, had a photo of himself and Jerry Dyer (in uniform) on his campaign brochure. Nobody complained about the Dyer/Duncan photo. Why is the Dyer/Perea photo be- Jerry Dyer, in uniform, had attended a Press Confer-

ing referred to as illegal?

During the KFSN interview, Dyer said, "I never want to use my uniform for political purposes because number one: it's against the law." Dyer said he has not endorsed anyone for mayor.


The legality of the photo in the brochure would be determined by an examination of the Hatch Act of 1939, which (according to Wikipedia) is a United States federal law whose main provision is to prohibit federal employees (civil servants) from engaging in partisan political activity. Named after Senator Carl Hatch of New Mexico, the law was officially known as An Act to Prevent Pernicious Political Activities. In this situation, the Hatch Act does not appear to apply. According to a Washington based Hatch Act Blog: "The law prohibits federal employees from engaging in political activity while on duty, wearing campaign buttons in the office and putting campaign bumper stickers on a government car. It also bans soliciting, accepting or receiving political contributions, and prohibits employees from using their official positions to influence or interfere with an election." If

ence announcing Henry T. Perea's candidacy, that might have raised some concerns. A public official and the police chief being in a photo together is not a Hatch Act violation.

What is a concern is that FPD officers operating under the "Color of Law" intimidated Democratic Party volunteers to remove campaign brochures from their booth at the Fresno District Fair. An investigation is under way to determine which officers were involved and to make sure that this does not happen again.

While researching this story, I was told by volunteers at both the Republican and Democratic Party booths that they were not allowed to distribute Yard Signs, Buttons, or Bumper Stickers. Fresno District Fair officials had told them that they were concerned that the Yard Signs and Buttons might be used as weapons and that the Bumper Stickers might be used to vandalize Fair property. The beer, marguerites, hotdogs on a stick (which is more of a weapon than an Obama button) were available everywhere on the fairgrounds and apparently not a danger to anyone. But, the Yard Signs, Buttons, and Bumper stickers were a clear and present danger - yes, a danger that democracy might break out at any moment.

Big Brother is Watching.

The camera pictured above went up last month just outside of the Fresno Center for Nonviolence (Van Ness and McKinley). There is already a camera at Shaw and Blackstone, designated "Peace Corner" because of all of the anti war demonstrations held there. The Fresno Police Department is rapidly expanding video surveillance in this city. They now have 90 cameras operating that are being actively monitored and recorded. They have another 24 cameras that they are able to use, but they are not (yet) being recorded. Of the 90 "actively monitored" cameras, 88 are south of Shaw Avenue. Not that we needed another reminder of *The* Tale of Two Cities, but doesn't it seem odd that almost all of the video surveillance cameras are in the "less affluent" part of town? # **Before You Vote You Need to Know this**

And instead of reforming what happened in Florida it basically institutionalized all the problems that happened in Florida. And institutionalized a series of impediments that make it very difficult for democrats to register, for democrats to vote and then for democrats to have their vote counted.

One of these requirements under HAVA is called "the perfect match" and what that does is little known but it is devastating. A quarter of the voters in Colorado have just been removed from the rolls because of this just this one scam. And what it does is they use a computer system to compare your registration application to all other government records of you in the state. So they will look at your social security records, your motor vehicle records and any time you've had any interaction with the government and if there is any information on your voter registration that is different than the information on another government record that they find they remove you from the voting rolls.

For example, if I registered as Robert F. Kennedy Jr. and yet my motor vehicle license said Robert Frances Kennedy Jr. I'd be removed from the rolls. If your initial is different, if you leave an initial out, if you leave a "Jr." out, if you leave a hyphen out in your name. And what they've done is a study in New York that said 80% of the errors are errors that were done by state clerks who are taking down this information.

Pap: Are the democrats suing to stop this?

I vote. Some of my best friends are voters. I have nothing against voting, and I plan on voting in the upcoming election.

But we shouldn't make the mistake of thinking that the most important political moment in our lives comes in the voting booth. Instead, we should take politics seriously, which means asking considerably more of ourselves than the typical fixation with electoral politics.

First, I won't be coy about this election. I voted for Obama in the Texas primary and will vote for him in November. I am a leftist who is consistently disleadership of the Democratic Party and I have no illusions that Obama is secretly more progressive than his statements in public and choice of advisers would indicate. But I think that there is slightly more than a dime's worth of policy differences between Democrat and Republican, Obama and McCain, and that those differences that are important in this election. Traditional grassroots political organizing to advance progressive policies on issues is more important. And even more crucial today, I believe, is the longterm project of preparing for the dramatically different world that is on the horizon - a world with less energy to deal with the ecological collapse; a world in which existing institutions likely will prove useless in helping us restructure our lives; a world in which we will need to reclaim and develop basic skills for sustaining ourselves and our com-

> These challenges are daunting but also exciting, presenting us with tasks for which the energy and creativity of every one of us will be needed. Can we find a way to talk about that excitement that could en

velop projects to put those ideas into action? When I have tried to articulate this worldview in plain language in recent political talks, I have found that a growing number of people not only will listen but are hungry for such honesty.

I won't pretend that number is large right now it's certainly not a majority, and not anywhere near the number needed for a mass movement — but one wouldn't expect that in this affluent society in which many people are still insulated from the worst consequences of these systems. But that's changing. As more and more people, from many sectors of society, face these realities we will see a search for a community in which to confront this together. Our political work should focus on connecting with people on common ground, and then working to shape a radically new vision of justice and sustainability.

So, I'll vote. But I will spend my time before and after Election Day talking realistically, to anyone who will listen, about radical change.

We are closer than ever to having Public, Education, and Government (PEG) access channels in the Fresno/Clovis area. If you are not clear about what having PEG access channels would mean, see the box on this page.

If you currently have Comcast cable, you can see that we already have two Education channels (ch 96 and 98). Channel 96 also operates as the City of Fresno Government channel where you can see City Council meetings on Tuesday. Channel 95 is the County of Fresno government channel. Channel 97 will probably be where the Public access channel is located.

Perhaps the most significant development, in the last few months, is that the money from the franchise agreement (between the cities of Fresno & Clovis and Comcast) has started to roll in. The first payment to Fresno and Clovis arrived about a couple of months ago. We expect to receive about \$600,000 a year, which will be used to operate the PEG project. Before this money is used for PEG, Fresno and Clovis need to establish a Joint Powers Authority (JPA) that will determine what entity will operate PEG. We expect the JPA to designate the Community Media Access Collaborative (CMAC) as the 501 c 3 that will run PEG. For more information about CMAC, go to: www.cmacfresno.org

There will be 3 JPA board members from Fresno and 2 from Clovis. If the JPA designates CMAC as the entity that will oversee PEG (which everyone expects will happen in the next month or two), they (CMAC) will begin to establish a Community Media Center (CMC), purchase needed equipment, hire staff, and get the Public access channel on cable.

CMAC is looking at several locations that will serve as Community Media Centers. All of the sites under consideration will operate through partnerships with existing organizations and serve the community by providing a location where programing can be produced. Right now, while no CMC sites have been finalized, there are three locations that look promising. There is an existing studio at the Kreman Education building at CSUF that could serve as the Public access CMC. One advantage of the Kreman location is that the studio is already built and partnering with CSUF would mean a faster start up time for the Public access channel. Also, there is staff on site that could potentially train community members in the use of the equipment. They are also connected with Comcast through high speed fiber that would allow programing to originate from that location. The negative aspect of the CSUF site is that parking is difficult and it is not centrally located.

The second site that CMAC is looking at is the Dickey Community Center on Divisidero near Blackstone. The Parks and Recreation department runs the facility and has already built a video production facility on the second floor. They have invited CMAC to partner with them to make the facility operational. The advantage at Dickey is that it is centrally located, there is good parking, and Parks and Recreation intends to attract disadvantaged youth to produce community media. The disadvantage to that location is that it is too small to serve as a primary CMC and it doesn't currently have connectivity (through high speed fiber) with Comcast.

The third location being considered is the Fresno County Office of Education (FCOE) building in downtown Fresno (Van Ness and Fresno Street). At this time, however, that facility would only be for Government and Education production.

It is starting to look like there will probably be more than one CMC as PEG gets off the ground in Fresno/Clovis. Probably, within a couple of years though, a central CMC site will be established where everyone will work from. There may still be satellite centers that will benefit particular constituencies and allow PEG to serve people who are geographically distant. But, the concept of one central CMC has a strong appeal, because it will limit duplication of services and allow CMAC to leverage limited resources. Why build and fully supply two or three CMC's with equipment, studios, and staff when you can have one central CMC and portable equipment available at a couple of satellite locations?

One of CMAC's biggest challenges is how to run PEG operations on \$600,000 a year, given the current interpretation of the franchise agreement is that the money can only be used for capital expenses. How do you pay for staff if you can only spend money on capital expenses, like cameras, computers, etc? That challenge is one reason why we have Educational and Government channels currently on cable but are still waiting for a Public access channel. Both E & G have staff that can produce the programs and get them on the air. Without funding to hire staff, the Public access channel is at a serious disadvantage. Fortunately, CMAC is committed to making a Public access channel a part of PEG operations in Fresno/Clovis. This will be accomplished by exploring a variety of approaches including in-kind partnerships with public and educational agencies, production service agreements, user fees, grants, memberships and community-based fundraising activities.

The County of Fresno signed an agreement with Comcast before the new state franchise agreement went into effect. At this time, the County of Fresno is not a part of the Joint Power Authority with the Cities of Fresno and Clovis, but they might join at sometime in the future. It is also possible that other communities like Selma, Reedley, and Fowler will join the JPA.

# What is Public, Education, and Government (PEG) Access Television?

The Public channel will provide programming produced by, nonprofit organizations, community groups and individuals. A program on the public channel could be about tenant rights produced by Central California Legal Services, it could be a cultural presentation of Hmong dancers, or an individual could produce a show about local politics. In short, locally produced, independent, and alternative video will have a home on the cable network.

The Education channels will be used primarily by the schools for education and distance-learning purposes. If you tune in to channel 96 or 98 you will see the beginning of the local education/government channel. Channel 96 & 98 are the forerunners to PEG. In an agreement reached a couple of years ago between Comcast, the schools, and the City of Fresno, it was agreed to set up these channels. Right now, you can see coverage of Fresno Unified School Board meetings, electronic field trips, University of California programming (UCTV), the NASA Channel, the Annenberg channel, and the entire Fresno City Council session each Tuesday. It is expected that more local education and government programming will be on this channel soon.

The Government channels (ch 95 & 96) are broadcasting city council meetings and board of supervisors meetings. Soon, it is expected, they will broadcast planning commission meetings, produce special programming about government affairs, and more. The government channels are the community's window into what is happening in government.

There would be an advantage to these smaller communities to join CMAC so they can provide PEG in their community. The money generated from the franchise fee in Fowler, for example, might not be enough for them to establish a CMC and run PEG. But, joining together with CMAC would make it possible to produce programing and provide PEG services in a small community.

Sources on the CMAC board of directors say they are hopeful that PEG equipment will be purchased in the 4<sup>th</sup> quarter of 2008 and that a Public access channel will be on cable by the end of the year. We now have access to grant writers who are willing to help up make this happen. It doesn't take a miracle, just a few good people who have their hearts and morals in the right place. If you have any thing that you can afford to contribute, maybe a office, or a building that can be turned into a second hand store, where some homeless people can repair Items donated and begin to earn some money. Maybe a old pick-up, a lawnmower, a rake or two, a weed eater etc. etc. so some homeless people can start a lawn service. Maybe you have a idea that we can use to help a homeless person. I not saying, by any means that we will end homelessness, ever, I mean Never in our life time. When I do the math, my numbers look like this. There are approximately 10,000 homeless people in Fresno County, which is a average count by most homeless people, homeless advocates, and general, in the know, average population of Fresno County. Homeless people, and homeless advocates in general, agree that there are approximately 16,000 or more homeless people in Fresno County. Fresno County and City dis-agree, at least for now so they say.

On the 7th. Of December, 2007, Philip Mangano gave a presentation here in Fresno, California before Mayor Allen Autry, some members of the City Council, some members of the board of supervisors, County, Chief Dyer, and a number of other people. I was there also. His goal was to convince the city to implement a plan to end homelessness in ten years. Fresno agreed to create a plan to end homelessness in ten years. This plan was to be presented before the city council and the county board of supervisors for approval in 100 days. The Mayor, Alan Autry, several city council members, several county board of supervisor members, the chief of police, Jerry Dyer, and several key players in the city, (key players, - people with cash). Calling themselves the Leadership Council, selected 32 people to form the Planning Council. People from all walks of life were selected to be on the Planning Council. Of the 32 Planning Council members, 2 were homeless, Big Sue, and myself, 3 for sure homeless advocates, 3 maybe 4 more council members seem to lean toward homeless advocates. The remainder of the planning council was a stacked deck for you know who. Then came the Ramsey Group to advise the planning council, at a cost to the city, and or county of \$40,000 for 100 days to advise us, the planning council. Personally, I thank the Ramsey

So I made a successful attempt to educate them. I took them on a real live tour to the ditch, so they could talk with the homeless, stand in their tent door way, mingle with them, etc. etc. We did two tours. First tour was Roeding park, with FOOD NOT BOMBS, and the homeless we feed every Saturday. January will be 14 years feeding the homeless, just come and eat, no conditions. The second tour was the H st. encampment, of the homeless. Then we went to the Poverello House. It was show time at its best. Red carpet and all. Tom Richards, the chair of the planning council, got a real taste of how the Poverello House really is when separated from the group inside the iron gates and fence of the Poverello House. Since we were dressed casual, the Poverello House Disciples assumed that the two of us, Tom Richards, and I, were just homeless people, we got the real treatment that homeless people get. It wasn't pretty. When I told them we were part of the tour, the Red Carpet came back out. Amazing, don't you think. My question is. Why is the City, and County of Fresno handing out thousands and thousands of dollars to people, Czars, and groups who know very little, or near nothing about homeless people, except that they are homeless?

> I dis-approve of the ten year plan that the City Council, and the County Board of Supervisors approved. As a homeless person at the time, I insisted that my disapproval be made a matter of record before both City Council, and Board of Supervisors chambers. Why? The City Council, and the County Board of Supervisors accepted a 10 year plan that says there are only 4,247 homeless people in Fresno, which we all know, including the City Council, and County Board of Supervisors, is wrong. Why did they approve a lie? They accepted and approved a lie because, so they say, H.U.D. would not approve a grant in excess of 4,247 homeless people. I spoke personally with the Supervisor of H.U.D. and when I complained about the numbers, his reply was he knew nothing of the 4,247 number, and that he agreed with the 10,000 or more homeless. There is something wrong with that picture. Fresno's 10 year plan to end homelessness will never work. It's a total joke. Even the Board of Education reports that there are 3,000 homeless children in Fresno Co. It appears that our public officials can't do the math. No wonder our budget sucks.

# Without Housing, **Without Rights A Question of Accountability**

In 1933, when more than a million Americans were homeless, President Roosevelt's New Deal made their economic and social well-being a federal responsibilty. In 2008, an estimated 3.5 million Americans will live without housing; homeless children in school number more than 900,000 according to the Department of Education. Ironically, in this election year – which marks the 75th anniversary of the New Deal - neither major party nor presidential candidate has acknowledged a federal responsibility. It is time that they do so.

The federal government created the contemporary crisis of mass homelessness by cutting and refusing to restore billions and billions of dollars in funding for affordable housing programs. Since 1982, every federal plan to address homelessness has failed because every plan has been based on the assumption that something was wrong with the people who were finding themselves without housing. Every plan has focused on individuals; FEMA emergency shelter plans, HUD Continuum of Care plans and 10-Year Plans to End Homelessness as spearheaded by the Bush administration's Interagency Council on Homelessness all identify homeless people as "the problem" that needs fixing.

The reemergence of massive homelessness is unrelated to any lack of outreach or case management. The simple fact is that homelessness reappeared because funding for federal affordable housing programs has been cut by \$54 billion a year (in 2004 constant dollars) since 1978. The number of people without housing has increased steadily since then.

As local governments have become more and more hard-pressed to shelter - much less house – this ever-increasing homeless population, many have turned to draconian measures to solve their "homeless problems," and poor people Without Housing are becoming poor people Without Rights.

#### From "Quality of Life" to Economic Cleansing

Local efforts often start with innocuoussounding language about the "quality of life" of the housed and business sectors of

the community, or perhaps are billed as an effort to ensure that communities don't become "magnets for the homeless." But over time, more laws and ordinances get passed, and as these are implemented it is only under very stringent "time, place and manner" restric-

and state police departments that homeless people are tolerated – if at all.

The most common public space and activity restrictions are those aimed at camping, sitting, lying or trespassing on either public or private land, panhandling, sleeping, blocking the sidewalk, jaywalking and possessing "stolen property" (shopping carts and milk crates) – to name just a few. All have one primary common goal: to remove from local communities people

in a community. In fact, however, enforcement is very much impacted by skin color, disability or appearance.

#### **Infractions and Due Process Rights**

Anti-homeless laws and ordinances and their application have created a loophole that allows for the circumvention of a homeless person's right to due process under law. The process by which homeless people face repeated incarceration generally follows this scenario:

> A homeless man is sleeping outdoors. A local ordinance makes it illegal to do so. The man gets a ticket for the infraction. Because it's not a jailable offense, he is not entitled to legal representation. Because he doesn't appear in court or simply can't pay the fine, a misdemeanor warrant is issued. When he is cited a second time for a similar violation, the outstanding warrant results in arrest. He spends a couple of days in jail, and when brought before the judge he is sentenced to time served, or his case gets dismissed. Now back on the street, he is just as homeless as he was before, but now he has a criminal record, which denies him access to the services needed to exit homelessness.

> Local governments know that these infractions will ultimately lead to unpleasant interactions with police - and incarceration – and therefore feel confident that a strong enough police and private security presence will get homeless people to leave areas where they are not wanted.

whose mere presence they deem objectionable.

This nationwide practice has escaped civil rights protections because, on their face, these programs are not clearly discriminatory. Local laws are often drafted in tions that are enforced by private security and local such a way as to appear to apply equally to all people

#### The Real Crime

Just like anti-Okie and Jim Crow laws of the past, local government programs designed to remove "undesirable" people from their communities violate civil and human rights.

Fact: Compared to 1978, the U.S. government is now spending nearly 65 percent less on developing and naintaining affordable housing for poor peop billion was appropriated in 1978, while only \$29 billion was allocated in 2005.)

Fact: The number of "mental health courts" has grown from two in 1997 to more than 100 today. Meanwhile, the top three residential mental health care facilities in the nation are: Los Angeles County Jail, Cook County Jail (Chicago), and Rikers Island (New York City).

2008 marks the 75<sup>th</sup> anniversary of the New Deal. FDR used the power of his office to marshal the resources of the federal government to address the housing, health care, educational and economic security needs of poor and homeless people. He lobbied for "decent homes for which there is a distressing need among [those] of our population [who are] ill-housed." Our current presidential candidates must be urged to do no less.

[Editor's note: The case of Carlo Parlanti has attracted worldwide attention, particularly in Europe. How interesting that so few of us living in the Central Valley (where he is incarcerated) know nothing about him, his case, or the extraordinary efforts being made to hold a new hearing. Supporters say that new evidence will prove his innocence. The following article, a Community Alliance exclusive, comes to us from Italy.]

He has been locked up for four years in the Avenal State Prison. In Italy, he is the symbol of the innocent unjustly detained. His story is so well known that even a group of European parliamentarians have decided to take part to clear his name and demand his freedom. His name is Carlo Parlanti. He was born in Montecatini Terme, Tuscany, and he has become one the most blatant examples of unjust detention at an international

When entering his name in any search engine you will get thousands of sites, blogs and videos telling his sad story. Even in China and Taiwan there are videos dedicated to him. Carlo Parlanti was accused of rape and kidnapping. His arrest took place in July 2004, while he was in Düsseldorf, Germany, waiting to board a flight to Italy, where he was employed.

In the period between 2002 and 2004, the time when he was (allegedly) a fugitive, Carlo Parlanti travelled to work in different countries such as Canada, England, Ireland, and Gibraltar, without anyone notifying him that an international arrest warrant had been issued against him.

Carlo Parlanti remained in German detention for months despite the lack of evidence against him. Germany made a request for evidence to justify detention beyond the mere complaint of his alleged victim and, even though German authorities received only a generic report, they decided to extradite Mr. Parlanti to the United States.

In December 2005 the trial began in Ventura County, which had jurisdiction over the case. Mr. Parlanti's Italian criminal record was counterfeited, stating that he was accused of armed robbery and rape in Italy. But the Italian criminal record that was acquired when Parlanti had already been in custody in Germany for months was spotless.

Despite all of this, Carlo Parlanti was sentenced to nine years' imprisonment. His case became internationally known largely because the trial transcripts, which are posted online, show a total lack of evidence against Parlanti. Many believe that Parlanti's right to a fair trial was violated.

By looking at the online records you will notice the absence of a medical certificate attesting to the violence suffered by the alleged victim (during a medical examination, the doctor couldn't find signs of the alleged violence) and the total contradictions of the accusations with the evidence found at the crime scene. The unreliability of the accuser during the hearings, already sanctioned by the court of another state, also calls into question that the crime took place.

Because of these contradicting stories, dozens of people met in spontaneous committees in order to help Mr. Parlanti. Even some politicians have decided to take part in order to put a spotlight on all the inconsistencies of the trial.



How many Californian's have ever even heard of Carlo Parlanti? Yet, there are protests in Europe to Free this prisoner being held at the state prison in Avenal, Ca (60 miles southwest of Fresno). Find out why.

The first to take part and give his political and personal contribution was Umberto Guidoni, well-known astronaut and now Italian Parliamentarian at the European Union. As first petitioner, through a bipartisan appeal to the Italian and European government, he asked to clear Mr. Parlanti's name. Other Italian politicians have helped, among them Marco Zacchera, who personally went to the USA to see the conditions at the Avenal prison, and Gino Bucchino, who has given his personal and economic contribution to help the Parlanti's family. Thanks to these politicians, Parlanti's case has attracted international attention, thus focusing wider public attention on the conditions of Parlanti's detention.

As previously mentioned, Carlo Parlanti is currently held in Avenal State Prison, 60 miles southwest of Fresno.

Avenal is the most populated prison of the state: it was designed for about 3,000 people; it currently houses more than 7,000. The life of Carlo Parlanti is marked by counting and by the typical experiences of each prison: food delivery, mail delivery, the ability to enter and exit the yard, and working within the prison.

Carlo Parlanti is in a protected yard, together with other people accused of sexual offenses. This is to protect him from possible attacks from the general prison population, which often attacks people charged with similar offenses.

Parlanti has suffered both psychologically and physically under detention. He has developed a lung infection of unknown origin that has cut in half his lung capacity. While in prison he also contracted hepatitis C, which has further undermined his health. The prison bunk has exacerbated the bad case of sciatica he suffers because of the crushing of two vertebrae.

Carlo Parlanti, unlike the other detainees, has the chance to see his loved ones only if they manage to find the necessary means to fly half way around the world. The only contact he has with his friends, family, and the people who support him is through phone calls, which are restricted because of his status as a prisoner. Through these few minutes of conversation he can feel the affection of his loved ones, discuss his case, and continue to fight in order to prove his innocence.

What strengthens Carlo each day is the ability to continue to fight for his innocence. In his suffering, he manages to help his companions too: he created the Avenal Voice blog, (http://avenalvoice.blogspot.com) where one can find poems and art works of the prisoners of Avenal.

Through this blog a prisoner of the same yard where Parlanti lives was able to get back in touch with his family when his family read an article in which Carlo named this particular inmate.

The person who is writing this article is one of the people who read the story of Carlo Parlanti on the Web, read the transcripts and pleadings and documents related to his case, and was struck by the innocence of this man and his strength of mind. A woman, like dozens of other women who have formed a spontaneous committee to assist Parlanti in order to put an end to this miscarriage of justice! There is no need to list the reasons for which we (the above politicians and I) believe that Carlo Parlanti is innocent. We can more easily show the reasons to you.

The published transcripts of proceedings on <a href="http://">http://</a> www.thepeoplevscarloparlanti.com prove the many inconsistencies that have characterized the stories of the alleged victim through the different hearings. You can see that witnesses, including policemen, have pointed out that the alleged victim, who declared under oath that she had been savagely beaten, showed no evidence on her body; they also pointed out that the home, which should have been a "war camp" according to the victim's statements, seemed perfectly in order and also the bed, described as "a pool of blood," mattress included, appeared clean and that no stain of blood or signs of a brawl have been discovered by criminal scientific investigators. We can also show to you, the readers, Carlo Parlanti's Italian criminal record at http://www.carloparlanti.it/Public/fedinapenale.jpg (it is clean and he was never charged with any offense).

You can see with your own eyes at <a href="http://">http://</a> www.carloparlanti.com/leaflets.htm the pictures of the alleged victim. Those pictures show how they were taken in different time periods; we can also bring to your attention the many inconsistencies of a process in which justice has not won. That's because an innocent man, Carlo Parlanti, continues to have crimes perpetrated against him, denying him the basic human rights that everyone deserves — the right to health and to a



The California Code of Regulations (CCR), Title 15, Division 3 (rules governing California's prison system) explains in Section 3007 under "Sexual Behavior" that:

"Inmates may not participate in illegal sexual acts. Inmates are specifically

excluded in laws, which remove restraints from acts between consenting adults. Inmates must avoid deliberately placing themselves in situations and behaving in a manner, which is designed to encourage illegal sexual acts."

A July 18, 2008, memorandum signed by R.K. Wong (Chief Deputy Warden Solano State Prison) for Warden D.K. Sisto, explains that a "Warden's Forum" will be held on 7/22/08 and 7/24/08. One of the topics to be discussed was "The Sexual Barrier Device Pilot Project" (TSBDPP). What the memorandum did not reveal was that the TSBDPP is a program that will begin handing out condoms to a group of prisoners in Solano State Prison. This gives a whole new meaning to the old aphorism, "Don't pick up the soap!"

OK, let's talk about this for a minute. As you read above, the rules clearly dictate that it is a crime to indulge in any sort of sexual contact with other prisoners. The rule reads, "...avoid... situations... designed to encourage illegal sexual acts."

The California Department of Corrections and Reha- will now have access to a cover up with the assistance

rubbers to prisoners is to help prevent the spread of the HIV and the hepatitis C viruses. There is no doubt these enfeebling viruses are a huge problem behind prison walls; no one disputes that. There are other more virulent activities in prison, in comparison to the occasional occurrence of prisoners having sex, that eclipse the number of those being infected with viruses.

Shooting dope! Why doesn't the CDCR stop this method of spreading deadly infections by passing out clean needles? Drugs are illegal just like sex is behind prison walls. What is the legal difference between passing out needles and passing out condoms? There is no legal difference! Providing a source of protection (condoms) to one activity that spreads a virus and not to another, more predominant cause of infection (like dirty needles) is profoundly equivocal and takes attention away from the real problem. It is well known that as many as a dozen people will use the same needle in prison. New, clean needles would help stop the spread of these deadly

Tattooing is another immense problem in the spreading of infections and diseases in prison. Every other person in prison has a tattoo or ten. Why not set up a controlled program where a prisoner can obtain a tattoo in a germ-free environment, replete with approved and sanitized tattooing equipment? The system will pay for itself as prisoners would be required to purchase the artwork with their own funds. Where is the logic in not promoting this disease prevention program?

Another scenario to consider, and it's not as farfetched P.O. Box 4000 as it may sound, is the occurrence of a prisoner being raped: sodomized or forced into oral sex. The offender

bilitation (CDCR) will be telling the public that issuing of the new prisoner condom program, provided by the CDCR and Gov. Arnold Schwarzenegger. The offender can obtain a free condom, perpetrate the crime, and then flush the DNA evidence into oblivion. Then it's one prisoner's word against another. Won't that be interesting in a courtroom trial? Should the prison staff member who issued the condom be an accomplice to the sex crime? How about the warden? Should he or she be implicated vicariously for assisting and providing the means to destroy evidence?

> Will it take this type of situation to make prison officials, the federal medical receiver, and the governor understand that a prison condom program is an asinine one? Have they ever heard of prioritizing? Passing out condoms will not ameliorate an effort to slow down or stop the spreading of potentially deadly diseases. There are more negatives than positives to this new condom scheme.

Spending taxpayers' money on a free condom program, promoting and condoning illegal sex among prisoners, is just plain bizarre and way off beat, even for the California Department of Corrections and Rehabilitation.



Taxi to the Dark Side is a horrifying documentary about an Afghani cabbie, Dilawar, who was detained in Afghanistan in 2002 and died in American custody at the prison in Bagram a few months later. Though Dilawar was never charged with any crime — and was never shown to have any connection with Al Qaeda or the Taliban — he was subjected to horrifically harsh treatment: deprived of sleep; suspended from a grated ceiling by his wrists; kicked and kneed in the legs until he could no longer stand. Taxi raises disturbing questions about interrogation techniques and U.S. wartime policies. There is an evident temptation, among many journalists as well as politicians seeking to replace Mr. Bush, to close the book and move ahead, an impulse that makes the existence of documentaries like Alex Gibney's "Taxi to the Dark Side" all the more vital. If recent American history is ever going to be discussed with the necessary clarity and ethical rigor, this film will be essential. The film includes remarkably frank interviews with American servicemen, some of whom faced courts-martial in connection with Dilawar's death; with a fellow prisoner at Bagram; and with Carlotta Gall and Tim Golden, who reported on Dilawar's story for The New York Times.— A. 

# **CREDO**—profiles of Fresno's progressive elders

**By Richard Stone** 

After 90 minutes in conversation with Venancio Gaona, the descriptive phrase that comes to mind is "a gentleman". Not that he comes from the gentry—quite the opposite is out as "joyas"—jewels—not only for himself but for many true. But despite financial insecurity and a disrupted family, Venancio was raised to the gentlemanly values of humility, dedication, courtesy and family loyalty. Bred to excellence and service, he has—for the most part unobtrusively—been countries as a rich heritage for us to take pride in. He also a major contributor to the civic life of Fresno, in the manner of true nobility.

Venancio attributes much of his character to the influence of family, and in particular his paternal grandfather, whose challenge remains the heart of Venancio's credo: "Haz tu vida con calma, paciencia, entusiasmo, y sobre toda diciplina. Haz las cosas con ganas" ["Make your way in life calmly, patiently, joyfully and above all with discipline. Whatever you do, do it with gusto."]

Venancio goes on to say that his grandfather's stock response to complaints that something was too hard or too timeconsuming was, "When you die, you can rest." And, he adds, "to this day I rarely sleep more than four hours a night." Venancio's native abilities were tested early by frequent moves (he was raised by his father, but in several different family households) including a 2 ½ year stay in Mexico that left him well behind grade-level in his studies. But those early hard experiences led also to understandings that have endured and guided his life: Family is your refuge, but selfreliance is your necessity. The world is full of inequity and it is a responsibility to oppose it; adherence to the faith of the Church and respect for others are essential.

returning to the States, Venancio was able to leap forward

with his studies and gain the notice of a doctor who took care of him during an illness. "This man, Dr. Carr, sponsored me through several years at a private parochial school until by my junior year, I could work enough to pay my own

In college, he was guided by counselors to prepare for a teaching career...which he in fact pursued first as a high school instructor, then as a professor at Fresno City College. While a student at Fresno State, he encountered several teachers who encouraged and aided his studies. Two of these he singles others, especially Hispanic students. One was Dr. Jose Canales, a history professor. "He made history applicable to I think it would be fair to say that Venancio has successfully our lives, especially in teaching us to view Latin American allowed me to take tests in Spanish until I gained confidence in my English." The other was Dr. Jose Elgorriaga, who shepherded Venancio through a Masters program and was the model of a mentor that Venancio strove to replicate in his own professional life.

Venancio's involvement in community affairs was gradual and circumstantial. "I never saw myself as a leader or organizer; but when I became aware of injustices in my surroundings, I'd seek out others opposing them or building alternatives. And I guess because I had ideas and wasn't afraid to speak out, I'd often be asked to be a spokesperson or

Much of Venancio's work as a change agent has been directed at educational opportunities for Latino youth. He and his associates worked for bi-lingual education, for services and support programs for children of migrant workers, for the establishment of Chicano/Latino studies programs, for scholarships specifically for Hispanic college students. Groups he has helped found or been strongly identified with (e.g. El Concilio de Fresno, and Concerned Citizens for Representative Government) have effectuated changes in hiring and promotion at Fresno Unified, the police and fire departments, City Hall and the County. "We were able to support Given this early tutoring, it was not surprising that, upon successful Hispanic candidates, often for the first time, for several positions. For instance we backed the first Latino

school resource officer, the first Latino motorcycle policeman, the first Latino firemen. We had to overcome all kinds of artificial barriers and prejudices...and even to coach candidates how to interview effectively. At the time these things happened, they were real break-throughs."

Today Venancio still serves on several committees directed at civic improvement and the resolution of community problems e.g. Latino Educational Issues Roundtable, Cesar E. Chavez Adult School Advisory Committee, Fresno County Library Building Committee, Fresno County Latino Rotary, Fresno County Democratic Central Committee.

met his grandfather's challenge, and adhered to his principles with admirable consistency and persistence. But when I chided him that perhaps acting with gentlemanly restraint may not always be all that's needed, he replied, "Yes, that's something I've learned. When people continue to treat you with disdain and disrespect, another response is called for. I am not predisposed that way, but we must act knowledgeably according to where we are and who we're dealing with."

This is an answer worthy of one whose taste in music ranges from Beethoven and Mozart ("their music brings peace of mind") to 50's doo-wop; and whose favorite books include Don Quixote, Plato's Republic, and the works of Carlos Fuentes and Octavio Paz. It is an answer indicative of one who lives "con ganas."








I wished a dreamer didn't visit Memphis, the one whose ideas engendered spiritual light, illuminating every face they shone upon with hope and purpose.





# **Who Really Owns Fulton Street?**

In essence, any action that has potential impact on the integrity of the "contributing elements" of a listed resource is subject to the CEQA process, and thus might be prohibited as a result of the CEQA process. The bottom line for the city, according to the consultant: "in terms of annual revenue to the City of Fresno, in addition to fees and other benefits associated with a revitalized Downtown, the full build out and utilization of the Mall would provide annual sales tax revenue of \$1,748,760 and annual property tax revenue of \$4,702,500 for the City's coffers, or a combined total of approximately \$6,451,260 million per year. Assuming that development potential would be limited to about 50 percent of its long term potential, that would mean that the combined revenue from real estate and sales taxes would be reduced by approximately \$3,225,630. Thus, the potential economic impact from listing Fulton Mall on the National Register of Historic Places would be a loss in potential sales and property taxes of \$2,859,661 per year (in 2008 dollars)."

The clock is ticking for Fulton Mall. The city council recently voted in favor of reexamining a report prepared several years ago that recommended reopening the mall to vehicles. The Market Profiles report suggested some sort of reopening, in order to make the businesses on the mall more viable.

On the main thoroughfare of Puerto Princesa, Philippines, September 21, 2008, Sunday, 7:00 PM:

'Sir, bigyan niyo po sana ako ng siete pesos para mabuo ko ang beinte na pambili ng isang kilong bigas (sir, please give me twenty-five cents so I can complete half a dollar to buy two pounds of rice)," pleaded a scrawny boy, who looked about ten years old.

'Why are you on the streets begging?"

"We have no food at home. My mother is sick, so she cannot work. I'm the eldest and ..." he politely replied, as I struggled to hear his voice amidst the roar of passing motorcycles.

"Where do you live in Puerto?"

"Sir, our place is at the community of San Jose," he replied. My scant knowledge of the city vaguely placed the location beyond the range of the lowest fare when riding the motorcycle cabs, which makes it about an hour walk. I dug for change in my pants pockets and counted six one-peso coins, exactly one peso (two US cents) short of what he needed. A check of my wallet revealed that the smallest denomination bill I had was fifty pesos. Unsure if the right thing to do was to part with the equivalent of one dollar and six cents, I decided that I'd go to the store with him to buy the rice he claimed his family needed, thinking that giving him the rice was a better assurance that my donation wouldn't be used for something else, like candy. Conflicted with empathy and suspicion, I erred towards the give-goods-not-cash basis, although he didn't strike me as a drug user or boozer. A boy of ten? There have been reports of syndicates exploiting children who are forced to beg in the streets of Manila, capital city of the Philippines. But I'm in Puerto Princesa, a prime destination for eco-tourism in the country.

On our way to the store, our conversation revealed that his father abandoned the family some time ago. He had four other siblings. This day being Sunday, he said he wanted to find or beg for enough money to buy rice, since he wouldn't be able to go around early morning the following day, because he'd be in school. He answered fourth grade when I asked him what level he was in elementary school.

Interestingly he said that his mother didn't have the money to buy bananas, which they can then sprinkle with sugar, deep fry in oil, skewer on bamboo sticks, and sell on the streets, so that they don't have to beg. Banana-que, we call them in the Philippines. In opening this line of conversation, he might have been hus-

tling for more money. But I didn't think so. More than likely, he was aware of the city's campaign to put a stop to begging, mostly by children.

At some point I asked him if he was just fooling me. He answered, "Masama po gawin iyun (that is a bad thing to do)." The Philippine word "po" is a signifier of respect for people older than oneself, and this is uttered quite often by the youth of Puerto Princesa.

Before parting company, I handed him one-hundred forty pesos (three dollars) to bankroll his family's banana-que business. His faint smile spoke tons of gratitude. As I walked away, he asked "Kuya, ano po and pangalan mo (older brother, what is your name)?" I said, "Alvin, and what is yours?" "Miguel, po," answered my young comrade, whose politeness seemed to mask the urgency of the quest for his family's suste-

Clutching a plastic bag with the two video movies I rented (Gladiator with Russell Crowe and a mega-hit Philippine movie about love and marriage), I walked toward my well-furnished apartment. I glanced back and saw Miguel's thin frame, his bony hand holding a plastic bag with two kilos of rice, which was twice his goal. On coming home, my three cats, two kittens and their mom I named Gloria, will have to be fed. Miguel is bringing home rice for his four siblings and sick mom.

I cried a little, adding more to the deluge of rain, which had been going on all day. And I thought, "My little comrade Miguel, what sort of revolution should we do together when the time is ripe? Tell me and I'll join you. I hope I will be brave, noble, and gentle as you are."

Note: Alvin Valeriano of Fresno's Food Not Bombs left for home three months ago and is currently in the Philippines financing the economic activities of impoverished fisherfolk in Palawan province, Philippines. On the most recent expedition with his friends, they brought home 590 kilos of fish, hand caught by hooks and lines, over a 10-day period, while battered by two storms in the Sulu Sea area of the southern Philippines.



After a harrowing day of fighting the waves and winds whipped up by a storm, we celebrated with shots of brandy. Our crew members are muslim Badiaos, aka the sea gypsies of the Philippines.

These fish were caught around corrals, located about 250 feet deep. Our fishing method is considered "passive," as opposed to "active" methods that damaged these

# **Hurricane Relief for** Haiti, and Keeping a **Wonderful School Afloat**

Few nations in the world have suffered worse than Haiti from US control and domination. From the installation and support of the brutal Duvalier regimes, to US support for military coups against the elected president(s), even the kidnaping of President Aristide in 2004 to reestablish a more "compliant" regime.

In 2000, the Fresno Wheelchair Project was asked for help, and since that time, has sent several diesel generators, an entire school bus full of aid, approximately \$14,000 in donations, and a variety of tools and video equipment to sustain and strengthen the activists still struggling for a free and democratic system in their nation.

It was Haiti's misfortune to get hit by all 3 of the recent Caribbean hurricanes and a difficult situation has gotten more so. Over 20,000 homes were destroyed, leaving an estimated 150,000 people in dire circumstances, rebuilding with whatever resources they can muster.

Besides medical and material relief, The Wheelchair Project is now also sponsoring and supporting a school with nearly 500 students in Port Au Prince, a school where credentialed teachers get paid between 80 to 150 dollars a month, and where at least half the students attend for free, while others pay as they can, when they can.

The Wheelchair Project has collected medical supplies, literally thousands of pounds of school supplies and material aid. The Project now needs help to defray ex-

penses to ship a flatbed truck loaded with aid to Haiti A.S.A.P.

Further plans are underway to help the school set up a small business in construction supplies, thus providing both employment and a steady income for the school to

Founder Patrick Young is presently making an appeal to the citizens of Fresno to help with the transport of this aid, to pay the various fees with customs, and, of course, travel to Haiti to ensure things get to their proper desti-

Volunteers with mechanical skills are also needed to help prepare the truck as well as some small motorbikes that will make a part of the shipment.

With our help progressive Haitians will be able to maintain in the struggle for dignity and progress in this nation in transition. If anyone can open their hearts and their purse strings for this vital work it would be greatly appreciated. Contributions can be sent directly to:





## From the Greenhouse— **A Blunt Reality**

Okay, let's get real. The US conoil but possesses only 3% of its oil reserves. All the off-shore and arctic oil drilling—even if it were ### successful—can not possibly make up for such an overwhelming deficit. That leaves only two ways to confront and solve our critical energy crisis. FIRST: get serious about making the most of the energy we have—which

means conserving by using only energy efficient appliances and machines, insulating our homes and factories, and squeezing as many miles per gallon out of our cars and trucks as possible; and SECOND: realize that even with the infusion of off-shore and arctic oil, the supply of fossil fuel is finite and that we must start transitioning our economy and life-style from oil and coal to renewable energy sources such as wind, solar, hydro, geo-thermal, bio-mass and ocean wave power.

Dr. King Hubbard, the renowned geophysicist predicted that the world's oil production would peak around the year 2000, and that is exactly what has happened. Of the 98 oil producing countries world wide, 60 are now "in terminal decline." Get used to it folks, the amount of oil available in the world is declining, is limited, and ultimately is finite. Sure, we can probably suck out a little more from the Continental Shelf and from the arctic and limp along for a decade or two, but we simply have to realize that the only real long term solution to our energy crisis is to quit relying on fossil fuels altogether. There are plenty of other renewable power sources available. Anything short of transitioning into clean alternative energy sources now invites an unprecedented energy meltdown a couple of decades from now. And we do not need any more pseudo-scientists hired by the oil companies to tell us that our oil crisis is not "real," or "really not so bad," or mocking the overwhelming majority of conscientious scientists who are telling us otherwise. What we need is the courage to face reality straight on, slowly put our fossil fuel economy into the barn along with the horse and buggy and start changing over to renewable energy sources. THERE ARE PLENTY OF THEM OUT THERE—more than enough to run our homes, factories and transportation systems!

In an op/ed piece in The Fresno Bee, Congressman Jim Costa, outlined what could have been a great beginning to get our country started in the right direction. First of all, Costa wants politicians to stop their unrelenting "I'm totally right—and you're totally wrong" bickering. It is this kind of adolescent squabbling that makes it almost impossible to achieve any kind of beneficial solution. Both sides agree that our country needs to stop guzzling foreign oil. Both sides agree that there is no silver bullet and that whatever solution we come up with must be comprehensive and include all aspects of energy production, distribution and usage. Mature legislators need to be able to set aside their egos once in a while and really negotiate—not just try to "win"all the time. National ENERGY INDEPENDENCE is more important than pleasing lob-

But despite Costa's efforts, and even though the Democrats won on an intermediate bill that would have allowed drilling beyond 50 miles from the coast, sadly the latest news is that the Democrats conceded that since they did not have the votes to over-ride a threatened Presidential veto, they are going to allow drilling off shore. They seem to think that since gas prices are so high now and the voters are currently in a "drill, drill, drill" mentality fighting that trend would seriously hurt them in the election.

"I think it is awful," said Senator Dianne Feinstein. "But this battle is not over. We will come back and fight another day-that's for sure."

Representative Lois Capps, a Democrat from Santa Barbara, where a 1969 oil spill devastated the coastline, said, "I hope that when Congress revisits this issue next year with a new President, we can negotiate a compromise that respects the need to protect coastal states and puts our country on a path to a clean-energy future."

"The next election will decide what our drilling policy will be," said Rep. David Obey, chairman of the House appropriations Committee.

So it becomes even more important that we elect Barack



#### **US Policy on Iran is not about Democracy or Justice By Eric Parsons**



Last month I wrote that America was following a wrong course, even an evil one, whether Democrat or Republican was president and by fortuitous circumstance the October Smithsonian magazine carries a marvelously supportive article, Inside Iran Fury. I encourage you to read it but knowing that most won't I'm going to summarize it.

Iran was a center of power long ago but fell on hard times and in the 18th and 19th centuries was a whipping boy for Russia and England until Russia kind of fell on hard times and in 1872 England is sole pilferer. After WWI England tightens the screws that squeeze out oil until the people revolt and a stable boy ousts the English toady king. He begins to wrest the country from British control and sides with Germany in WWII which further tightens English screws until it squeezes out another revolution in 1951, Peaceful and done by parliament, the king, the son of the stable boy, is ousted and a man named Mossadegh is empowered. With popular support, he moves immediately to take control of the country's oil but England strenuously objects. Mosedegh, believing what we broadcast about being for justice and democracy, took his case to the United Nations expecting to win with our support. He was very wrong about American support but it looked like he might have his way with the country's oil. Churchill, worried that England would lose cheap oil, began to plot the overthrow of Mosadegh. Mosadegh found out and booted the British out in 1952. Churchill, frustrated, tried to enlist the USA as his bully boy for a piece of the pie and asked Truman to have the CIA do the Brit's dirty work. Truman refused, pointing out that the CIA was to gather information but not for

Before continuing with the article summary I want to note that the National Security Council, established by congress in 1948 along with, and in control of, the CIA, had issued policy statement NSC64 in 1952 that said that, for the highest ideals of justice and democracy, and because the soviets were so bad, operatives might go beyond information gathering to commit any act with no legal or moral restraint. This was a secret policy statement at the time and maybe Truman didn't know about it or maybe he was just the last honorable president. For what ever reason, that was the last time we stood for justice and democracy.

When Eisenhower took power in 1953 he appointed Dulles, a corporate lawyer with a deep prejudice against nationalization and Russia, as Secretary of State. Dulles was a sucker for Churchill's plot and immediately sicced the CIA on the popular government of Iran and on August 19, 1953, Mossadegh was imprisoned for the rest of his life and the son of the stable boy, Reza Shah, was reenthroned. We continued to split the oil with England while our man, the king, suppressed any of his countryman's objections with torture and murder so vile that, even though we supplied him with the most modem weapons of war and torture and as many as he wanted, the country rose en masse and kicked him, and America, out in 1979 after only 26 years.

There will be much more of this as energy investors build perhaps 40-50 gigawatts of generation (enough to run all of California and then some) in the Mojave Desert and build more and more huge transmission lines along increasingly ugly transmission corridors.

Perhaps "we the people" will learn something from the present economic crisis—that it is not practical to let Big Money and Big Corporations have their way with us and run the whole show. Their interests are not our interests, and if we are naïve enough to believe we share common interests with the corporations, we will pay and Charles M. Ashley we will suffer.

Our nation is at a crossroads. We can choose our future or let the corporations choose it for us. In the case of the electrical grid, we can choose to develop local generation projects — many small generators distributed widely so as not to have large environmental footprints and not to require long transmission corridors. Rooftop solar is the most obvious example. Why has "our" government not moved to make rooftop solar mandatory on all new construction and to partner with owners of existing buildings to add solar? Moreover, battery and other storage technologies are rapidly developing and soon will render the electrical grid obsolete.


