

#### CABLE ACCESS N O W !

Imagine a world in which the poor and the voiceless had as much of an opportunity to be heard as large corporations and the rich. Imagine a soapbox in Fresno large enough that free speech was more than just a quaint idea — it became a reality. The airwaves could be like that. Many years ago, radio and television were thought of as being in the public trust. The government regulated the airwaves and gave a license to owners who were operating the station in the best interest of the community. There was a Federal Communications Commission regulation called the "Fairness Doctrine" that held owners accountable to broadcast for the public good.

The fairness doctrine no longer exists. It was a victim of the Reagan administrations massive attacks that deregulated the industry, gave corporations more power, and let the marketplace decide what is best. This policy resulted in many corporate mergers that consolidated the media into a handful of huge multi-media conglomerates.

Ben Bagdikian, in his book The Media Monopoly, published in 1983, said that 50 corporations dominated the media in the United States. At the time, he was criticized for being hyperbolic and not having "faith" in the free enterprise system. In 1987, Bagdikian came out with the second edition. Fifty companies had become 28. A few years after that, in 1990, 28 had become 23. And then 14 in 1992. By 1997 the number was 10. And in the latest edition, which came out in 2000, the number is down to six.

The result of these corporate mergers can be seen in the blandness and homogenous nature of the media here in Fresno. There is a frightening sameness to the programming available. The media does not challenge us to question basic assumptions about how great corporations are and certainly does not give poor and minority voices an opportunity to communicate their message and share their reality with the community. The one exception is KFCF 88.1 FM but they can't be expected to do everything. That expectation leads progressive groups in this area to fight for the crumbs while corporate interests dominate all other communications.

Out of this frustration, a group from the Fresno Center for Nonviolence started a television show called "The Right Stuff from the Left." They were tired of being marginalized and misrepresented by the mainstream media. Tired of holding events to draw attention to an injustice and having no coverage of the event on TV or the radio. Groups in the progressive community began to feel that there was some kind of a conspiracy by local media to ignore their message. Even when a

reporter did attend an event they gave the spokesperson 10 seconds to explain a complex situation.

"The Right Stuff from the Left" went on the air May 5, 2001 and broadcast a 1/2 hour show every week through August 25, 2001. This effort, coordinated by Vince Lavery under the auspices of the Center for Nonviolence, was an eclectic mix of interviews with progressive activists and debates with representatives from the right wing of the political spectrum. The program, which was never boring, was different than anything else on television at the time. Out of this experience, which died an untimely death because of the high cost of buying air time, the idea of getting free air time on the cable network came to life. Looking around the state and the country local free speech activists realized that groups in other communities had their shows on television, were reaching thousands of viewers, and it cost them little or no money. The local organizers for cable access in Fresno decided to call their group the Cable Access Now (CAN).

CAN is organizing for Public, Educational, and Government (PEG) programming. PEG access is provided through a contract between the City and the company that provides cable television in your area. Why do cable companies provide PEG access programming? They do this because, in order to deliver cable channels to your home the cable company has to use public right of ways. In other words, they have to cross roads and other public property with their cable lines. The City will agree to allow them to have their lines cross public property but only if they sign a contract. The contract between the City and cable company usually includes a franchise fee and some form of PEG access.

In Fresno, the last contract between the City and Cable company was negotiated over 30 years ago. It was not a very good agreement, giving the community very little access to programming on the cable network. Of course, 30 years ago the technology was a lot different. They were not able to provide the number of channels now available through fiber optics, and multiple channels for PEG access was not in the contract. But times have changed and a new contract is being negotiated between AT&T and the City right now. The old contract will expire on December 31, 2004.

The City is already negotiating the new contract with AT&T. The good news is that the City staff is very knowledgeable about the process and all of the City Council members that we have talked to agree that we need better PEG access on the cable network. But this is going to be a long process.

AT&T does not want to provide Fresno with PEG access and will lobby hard to keep us from getting it. They have deep pockets and will bring to town highly skilled negotiators to lobby on their behalf.

The money and influence that AT&T has to keep us from having PEG access will be counterbalanced by community groups and individuals who care about free speech. We will tell our representatives on City Council that we deserve a contract that includes PEG access that is as good as those in other communities. Fresno should have at least one channel for public/ community programming, at least one for the schools and education, and at least one channel for government. AT&T should provide free studio space to produce the programming, give us access to the video equipment, and provide training so that community members can learn how to produce a show. AT&T will take millions of dollars out of this community in coming years - we are just asking them to be good corporate citizens and give us something in return.

It is essential that community groups and individuals communicate with City Council on this issue. They need to know that there is interest in this issue. There are three points that Cable Access Now (CAN) would like you to tell City Council:

- 1. We need to hold AT&T to the terms of the 1986 Memorandum of Understanding (MOU) which would give us immediate, but limited access to the cable network NOW.
- 2. The City of Fresno should hire a consultant to help negotiate the contract.
- 3. We want open public hearings to assess community needs for PEG access.

The applicable portion of the MOU, which is printed, in a side bar on this page directs the cable company to provide the community with access to the cable network that is comparable to the access we had in 1986. At that time, there were 20-25 locally produced shows on the cable network every week. Today, there are five. We demand that AT&T comply with the terms of this legal contract. The City of Fresno needs to hold them accountable. If this was done it would be a great step forward in gaining cable access in this community.

CAN is calling on the City of Fresno to hire a consultant to help them level the playing field in their negotiations with AT&T. Consultants who specialize in cable contract negotiations know all of the "tricks" that the cable companies try to use to get out of providing PEG access. They know how to counter the cable companies arguments (continued on page 4)

#### KFCF 88.1 FM IS HOLDING ELECTIONS

The Fresno Free College Foundation will be holding an election for our Board of Directors during November 2002. Candidates for election are now being sought. The procedures for elections were adopted by the FFCF Board of Directors to increase member participation and democratize the governance of the Foundation. The following guidelines will be followed for nominations and election of the Board of Directors:

- 1. A candidate must be a qualified member of the Fresno Free College Foundation. A qualified member is defined by our bylaws as an individual over 16 years of age who is a current subscriber to KFCF Radio or the FFCF for \$25 per year or more, and has submitted a signed membership card.
- 2. The nomination period will begin on September 3, 2002. Nomination applications must be submitted to the FFCF no later than October 16, 2002.

- 3. Any FFCF member in good standing may nominate herself/himself or another member.
- Slates of candidates are not permitted.
- 5. Candidates will provide a brief statement of qualification and vision. The candidate application form will be available from the Foundation office located at 1449 N. Wishon Avenue in Fresno, or one can be mailed upon request.
- **6.** The official 30-day campaign and voting period will begin on November 1, 2002 . Public forums and radio presentations will take place during this period. Campaigning will not begin until ballots are mailed out.

If your KFCF or Foundation membership is not current you may join with a contribution for \$25 or more. If you are a current KFCF subscriber but have not become a FFCF member, you need to contact the Foundation office for information about how you can join. # KFCF ELECTIONS, WHAT IS AT STAKE?

The Fresno Free College Foundation, owner and operator of radio station KFCF 88.1 FM, is having an election to select its Board of Directors. This election is very important for the progressive community in this area.

KFCF provides an invaluable service by re-broadcasting KPFA (Pacifica) from Berkeley. I have heard many people describe the station as a cultural and informational oasis. The news, analysis, music, and cultural information is not available anywhere else in this area. This is FREE SPEECH RADIO. We are indeed fortunate that we have this resource and owe a debt of thanks to the visionaries who started and have maintained the station all of these years.

What is at stake in the upcoming elections? As many readers of this magazine know, this election is happening a little more than two years after a very divisive and bitter recall election. The Community Radio Coalition, an ad-hoc group of progressive community activists, attempted to expel the old Board and replace them with a new Board. The CRC, who had four members on the KFCF Board of Directors, wanted:

 More local programming.
 Implementation of a community advisory board to determine programming needs.
 Moving of the studio to a location more easily accessible to the public.

The vote in the recall election was 306-282. The recall failed. While many FFCF/KFCF members were unhappy with the situation, the majority were not ready to recall the entire Board of Directors. Following the failed recall election all four members of the CRC left the Board. New Board members were selected by the Board majority and the CRC is no longer active.

While the FFCF/KFCF membership was not ready for such a radical change, the election did send a clear signal that a large number of members were dissatisfied with the status quo. Changes were made. Numerous new local programs were put on the air and a new studio is currently under construction in the Tower District. The CRC did not get everything that they wanted, but they didn't win the election.

The Community Alliance magazine encourages FFCF/KFCF members to participate in this election. If you care about alternative/community media and have the time and desire to serve on the Board — we urge you to take up the challenge and participate in this important election. It will be the work and support of people like you that will keep KFCF going in the right direction.


and give us the best contract possible. The City of Fresno has already requested open public hearings to determine public needs for cable access. Since the next contract will be in effect for as long as 20 years we need to be looking towards the future. We need to access not only what the community needs are now but also what they are likely to be in the year 2020. It will be critical that community groups and individuals attend these public hearings and go on record as being in support of PEG access. That way, when the City and cable company are in negotiations the City will be able to point to the testimony in these hearings as proof of community need. Otherwise the cable company will just say that the community has expressed no interest in public access. Without hearings it would be more difficult to counter that argument.

#### What can you do to help?

- Write and call your representative on the City Council and make the three points listed above.
- Come to the next CAN meeting which will be held on Thursday, September 26, 7 PM at the Fresno Center for Nonviolence, 985 NVan Ness.
- If you are really excited about the idea of cable access programming we would like to encourage you to dream a little. Imagine what kind of a show you would like to see on the cable network.

Then — call AT&T at 455-4289 and make a proposal for them to put the show on the air. CAN figures that if AT&T starts putting shows on the cable network that is a major victory. If they refuse then we have further evidence that they are not meeting community needs. In either case we win.

#### CLEARING THE AIR: Kicking the Fossil Fuel Addiction

... while we are officially recognized as the second worst air basin in the country, know this: we're the worst.

August was air pollution hell-month for San Joaquin Valley residents. It featured the worst episode of smog since 1998 and only the third such occurrence in 15 years. We were not alone. Weather-related catastrophes around the world due to global warming were also on the rise. The year 1998 must again be mentioned. It is the warmest year on record, but the first seven months of 2002 were warmer still. This year is on track to exceed 1998's average global temperature high mark. The connection between ground-level air pollution and greenhouse gases? Fossil fuel. The immediate need is to break this fatal addiction. Here's an overview of what's happening here in the San Joaquin Valley. You'll see we all have ample opportunity to make a difference locally and globally.

#### Campaign Website.

If you're ready to get involved in the California Clean Air Campaign, learn why our air is so bad, who's responsible, who's being sued and why, read the latest medical research, receive action alerts, we've got a website for you: www.calcleanair.org The California Clean Air Campaign is a coalition of community, medical, and environmental groups that are unified by a commitment to improving the health of Californians by enforcing the Clean Air Act in the San Joaquin Valley. We are the three Sierra Club chapters of the San Joaquin Valley, Medical Advocates for Healthy Air, Latino Issues Forum, Center on Race, Poverty & the Environment, and Earthjustice. Our site provides a wealth of educational resources about air pollution and its sources, its effect on our health, current news and legal actions, and information on what you can do to help. Check it out.

#### Act Locally, Act Globally.

Average global temperature rose by only 1° F during the last century, yet we are seeing catastrophic results already. Worse still, we are on track to see a 3-10° F increase in the next 100 years. In the month of August, reports from around the world have continued to sound the alarm:

- Following a heat wave that kills 1,000 people, flooding displaces more than 5 million people in India and Bangladesh.
- Widespread flooding in normally arid regions in China.

- The worst flooding in Europe in a century.
- Word Health Organization warns of coming pandemic of dengue fever.
- Center for Disease Control calls West Nile Virus an "emerging infectious epidemic" as the disease spreads to 35 states in the U.S.
- More than 5 million acres burnt in the western U.S.
- Tropical forests turning from carbon dioxide sinks to sources,

As Margaret Beckett, British Secretary of State for Environment, observed, "We've known for some time that we have to worry about the impacts of climate change on our children's and grandchildren's generations. But we now have to worry about ourselves as well."

Meanwhile, attendees of the recent Global Summit on Sustainable Development in South Africa, may not have been able to focus on climate change due to the Bush Administration's "learn to live with it" position, but they did see a six-minute film on air pollution in the San Joaquin Valley produced by German television. The piece highlighted our Valley's plight as a microcosm of the world's. By acting locally, we are acting globally. The most important actions for Valley residents to take this year

are to sign up for action alerts at www.calcleanair.org and for Fresno County residents to campaign against Measure C, the sprawl-inducing, auto-dependent transportation sales tax.

#### Worst Air..... Anywhere.

Finally, while we are officially recognized as the second worst air basin in the country, know this: we're the worst. The official designation is tied to the federal one-hour standard, which reflects ozone levels during the peak hour. An exceedance day occurs when 124 parts per billion are present. The more accurate measurement is the eight-hour standard. This averages ozone levels over the peak eight hours, and an exceedance occurs at 80 parts per billion. The San Joaquin Valley has held the No. 1 position for violations of that standard since 1999, and 2002 is shaping up no differently. From 1999 to 2001, we had a total of 323 violations for the three-year period, vs. 287 for L.A.-Riverside. The eighthour ozone average will become the new legal standard in the near future, and that point we will officially vault into the top spot.



#### **Forestiere Underground Gardens Concert**

A benefit concert for the Poverello House of Fresno is slated for the Forestiere Underground Gardens Saturday, September 21, beginning at 7:30 p.m. Performing that evening are Dave Alvin and the Guilty Men, and Glen Delpit and the Subterraneans.

The Underground Gardens, located at 5021 W. Shaw Ave. in Fresno, were designed and hand-sculpted by Baldasare Forestiere, a Sicilian immigrant. In the early 1900s, Forestiere began to carve a thoroughly unique underground retreat to escape the San Joaquin Valley's excessive heat. After nearly 40 years with hand tools and persistent effort he succeeded in creating a cool subterranean complex fashioned after the "visions stored in my mind." In the midst of the man made caverns, is a large banquet room Forestiere intended as an entertainment venue.

Dave Alvin is a Grammy award winning artist. He is regarded as "one of America's most gifted roots music songwriters." He has recorded eight albums on the Hightone records label. In 2001 his album "Public Domain" was awarded with a Grammy for Best Traditional Folk Album. His latest album "Out In California" captures the essence of his live performances.

"Playing live," he enthuses, "is that hour, hour and a half, two hours on stage when you're immortal, time stops. To me, when my band is on, which is a lot with the Guilty Men, my mom and dad are alive, I'm 22, I'm 87, Your legs do things they don't when you're walking to the store. You get runners high. How do you capture that on a record? You've got to do it live."

Glen Delpit and the Subterraneans are a Fresno based band and a local favorite. Glen writes original material for the band and his message often concerns the plight, struggles, and sometimes the redemption of the disadvantaged in our society.

# What were we doing on the morning of September 11?

And what have we done since?

#### SEPTEMBER 11

People always remember what they were doing when JFK was shot. People always remember what they were doing when the space shuttle Challenger blew up. September 11 will be the same. I was in the front yard watering the lawn before work and my neighbor came over and said, "a plane crashed into the World Trade Center." I thought to myself, "What? Why are you talking to me so early in the morning?" She said it again and wandered off. How strange. I went inside and woke my partner to tell her while I connect the antenna to our television which we rarely watch. We sat and stared at the TV, awestruck, as the first tower collapsed. A few months later we visited New York City and felt an urgent need to go to Ground Zero right away to try to recognize what had happened to this city of 9 million.

Later on the night of September 11, or perhaps the next night, a group of us met at the Fresno Center for Nonviolence. The group was small but the feelings were powerful. Fear. Anger. Compassion. Frustration. Sympathy. Shock. Horror. How should we respond? By this time the leadership of our nation was bent on revenge and destruction. I read a poem by Thich Nhat Hahn that he wrote after the bombing of Ben Tre and the comment made by an American military man, "We had to destroy the town in order to save it."

For Warmth I hold my face in my two hands.

No, I am not crying.

I hold my face in my two hands.

To keep the loneliness warm two hands protecting,
two hands nourishing,
two hands preventing,
my soul from leaving me
in anger.

-Thich Nhat Hahn

#### **OUR RESPONSE**

Fresno's progressive community had an immediate response to September 11 and to all victims of terror. On September 15 a march was organized to support our Muslim brothers and sisters who experienced an immediate backlash as a result of the terrorist acts. We marched from the Wesley Methodist Church of Fresno to Masjid Fresno and heard speakers at both locations. The hundreds of people and organizations that showed up for this march astonished me. Having just moved to Fresno a few months before, the commitment of the Fresno community comforted and reassured me. Children and parents; grandparents and teenagers; gay and straight; black, brown, and white; punks and clergy; all marched in solidarity waving signs and flags. By the following Monday (September 17), we had our first meeting to STOP THE WAR! at the Fresno Center for Nonviolence. Groups at Fresno City College and Fresno State were formed to educate and inform the community about terrorism, peace, and the Arab/Muslim community. On Wednesday September 19, the Unitarian Universalist Church held a talk on "Terrorism: Roots and Responses." Everyone in the peace community was working in different ways to address the crisis.

Many groups stepped forward in the initial months to respond to September 11. Church organizations, school and college organizations, and other progressive organizations, such as WILPF made their opposition to the continued violence known. Some groups acted within the framework of their existing organization, others sponsored talks and public statements. Of particular interest has been the **Women in Black** group that has sponsored a silent vigil every Wednesday from 12-1 at the County Courthouse. This group has helped draw attention to peace and for negotiated settlements of US military action.

#### PEACE FRESNO

One of the most significant changes to the Fresno peace movement was the formation of Peace Fresno. This group started as the STOP THE WAR! committee, formed the week after September 11. This group has gathered weekly at the Fresno Center for Nonviolence since September 11 in an effort to "seek effective nonviolent responses to terrorism" and to "explore and identify peaceful options in our search for justice."The meetings have ranged in size from 5 to 40 people. Commitment and passion are two words that come to mind when thinking about active members in Peace Fresno.

3 specific responses to September 11 have been sponsored by Peace Fresno:

#### Shaw and Blackstone a.k.a. "Peace Corner"

This has become the central meeting place for voicing opposition to the "war on terrorism." Since September 14, members of the community have met at Shaw and Blackstone every Friday evening to publicly voice their opposition to the invasion of Afghanistan, the treatment of Arabs and Muslims, the USA PATRIOT Act, and the potential invasion of Iraq. The very fact that people in Fresno have shown up on a street corner week after week for a year illustrates the commitment and the seriousness of these times. The honks of support have grown as the months of Bush's terror war have continued unabated.

#### Rally in the Valley

On March 22, 2002, Rally in the Valley took over Courthouse Park for a day. Over 800 people in the Fresno community showed up for a day of music, speakers, and informational booths relating to peace and social justice. Making this event a success was the hard work of Peace Fresno.

#### Vigil Honoring Victims of Terrorism

This event will take place on Friday September 6 from 6:00-7:30 PM at the Courthouse Park. To honor all victims of terrorism, participants will wear black and symbolically paint one hand blue to symbolize unity with all people and one hand red to symbolize the blood of the victims. We will stand silently to bear witness to the suffering of victims of terrorism around the world and light candles for peace. A brief message from Peace Fresno will conclude the event. This event has the potential to be the ceremony in Fresno to attend on the anniversary of September 11. Please plan on attending with your friends and family and spread the word.

#### STUDENT ACTION FRONT

Another group was formed in response to September 11 called the Student Action Front (SAF). In their own words:

"SAF felt that many leftist, progressive, and activist youth were afraid to speak what they felt about the war, as well as feeling alone in their beliefs. SAF was formed first as a forum for youth to be able to speak their feelings on this war with others as well as being educated about aspects of this war that have been kept out of the spotlight by mainstream media. Education will be our primary weapon against this war. SAF was also formed as a tool for networking students from different colleges and universities, junior high, and high schools, in order for students to learn new information and disseminate it to their student bodies as well as giving them information on how to organize anti-war groups within their individual schools. We also setup protests, workshops, send speakers into schools etc., and are willing to use any necessary means to seek social justice in the world."

This group has worked to empower the youth of Fresno and has sponsored workshops at the Fresno Center for Nonviolence during the past year.



#### **HOW 9-11 HAS IMPACTED IMMIGRANTS**

The ILRC works with a number of organizations in the Valley, including the San Joaquin Valley Coalition for Immigrant Rights. Both the Bush administration, through its Department of Justice and to a lesser extent Congress, have taken very dangerous actions against immigrants since September 11th in the name of enhancing national security. It is important to have a balanced view of these attacks on our basic civil liberties. On the one hand, they are serious, and we need to unite to oppose them. On the other hand, immigrants and their supporters should not panic. There have not, and in my opinion, will not be massive round-ups or deportation of undocumented immigrants. Finally, the September 11th attack has undoubtedly resulted in a delay, but has not eliminated, the effort to obtain a legalization (amnesty) law to benefit undocumented workers and their families. Immigrants and others should not lose heart. Our response needs to be two-fold. First, we should concentrate on organizing a response to selected new policies, where our response will help build the organizational strength of the immigrant and workers' rights movements. Second, we need to continue to aggressively continue our campaigns to obtain positive changes in immigration law and policy. It should be remembered; for example, that AB 540, which gives most undocumented immigrant students the same in-state tuition paid by others, was signed by Governor Davis in October, 2001 --- after September 11th. If we continue to build our unity and strength, we can win other victories as well. The government has taken these measures in the name of enhancing our security against future terrorist attacks. It is understandable that the American public and some well-intentioned policy makers feel so vulnerable after September 11th that they are support-

ing measures that do not improve our security but do result in significant deprivations of civil liberties and other basic rights of immigrants as well as others. At the same time, it is this writer's opinion that many in the administration and in Congress, such as General Ashcroft (oops...that's Attorney General Ashcroft) are playing on the justifiable fears of the public to pursue their own antiimmigrant and anti-civil liberties agendas. As one immigration attorney joked, "This year the leading antiimmigrant organization, the Federation of American Immigration Reform (FAIR) should give its annual award to the person most contributing to its cause to Osama Bin Laden." Actions by Congress: In October 2001, anti-terror legislation known as the USA PATRIOT Act went into effect. Among other things, this law gives the U.S. Attorney General the

power to certify certain individuals as terrorists, based on "reasonable information" that he or she is linked to terrorist activities. Once someone has been certified as a terrorist, they are subject to mandatory detention and will remain in custody even if they have a defense to deportation. This represents a very dangerous infringement on our basic constitutional due process rights. In November 2001, the Transportation Security Act became law. Among other things, this law requires that security screeners in airports be U.S. citizens. Under this law, thousands of workers who are lawful permanent residents but not U.S. citizens must be laid off from their jobs by November 19, 2002, unless they naturalize by the November 19, 2002 deadline. It is impossible for a person to even apply for citizenship until she has been a legal resident for five years in most

cases. Ironically, in airports such as San Francisco, the net result of this law will be to weaken our security because well-trained, experienced screeners will lose their jobs. Immigrant rights groups and others are engaged in efforts to support legislation to eliminate this silly and harmful requirement, which results in permitting the guys in uniform at the airport with machine guns (soldiers) to be non-citizens but mandates that the people right next to them who ask us to remove our shoes be citizens. Actions by the Department of Justice: The Following are just some of the actions initiated by the Department of Justice. In December 2001, the Immigration and Naturalization Service (INS) established a new policy for identifying persons who have been ordered deported but have not complied with their deportation orders. Under this new policy, the

INS will enter the names of persons ordered deported into the National Criminal Background Check System. This database, which is used to identify fugitives with outstanding arrest warrants, will now allow the FBI and local police and sheriff's departments to identify persons with deportation orders so they can be transferred to INS custody. This system is initially being implemented for those from Arab or Muslim countries. In a related measure, the Department of Justice has proposed to have local police and other law enforcement agencies assist in enforcing federal immigration laws. This proposal, as well as others by the Department of Justice, at the same time poses a threat and yet also provides an organizing opportunity to immigrant communities and their allies. In a number of cities, not only including "PC" centers such as San Francisco, but also Seattle, Portland and Santa Ana, either police or municipal authorities have stated that their local police will not be part of an effort to enforce immigration laws. To do so, reason these police and other local officials, would result in destroying the confidence and trust that the police must maintain and develop with immigrant communities in order to have crime reports, witnesses and other necessary cooperation to effectively fight crime. Residents in towns and cities throughout the Valley, as well as elsewhere, should consider whether it is a good opportunity now to raise with local authorities the importance of taking a similar stand on this issue. Different government agencies have recently put into practice a system that allows them to share the information in their respective databases. This allows INS agents at points of entry to have access to information stored in State Department databases about who has received immigrant or nonimmigrant visas from consulates. Conversely, consular officers abroad now have access to information in

INS and FBI databases at the moment visa applications are approved. This new practice of information sharing is designed to reduce the incidence of visa fraud. In December 2001, the Attorney General announced a new Justice Department policy requiring certain immigration court proceedings related to terrorism to take place behind closed doors. Another example of a Department of Justice proposal against which resistance can strengthen our longterm power is the proposed policy to implement requirements that legal permanent residents (e.g. those with green cards) submit information as to their change of address. This

Justice, but rather from the Social Security Administration (SSA). The SSA has been sending hundreds of thousands of letters to employers, noting that the Social Security Number for a specific employee does not match their records. Thousands of workers have already been fired. The first line of defense, where applicable, is the worker's union if he has one. If not, we have been circulating a ten page "Tips to Employer". We would be glad to make this part of a future newspaper article. Finally, it is important that undocumented immigrants continue to press for federal legalization legislation. The hope for a legaliza-



measure has upset thousands of legal residents. Community groups have a unique opportunity to hold parish and community forums, which not only explain the proposed new requirements, but invite these legal residents to participate in community based efforts to change immigration policy and law. This proposal is more evidence that whoever came up with it at the Department of Justice is "a few loafs short of a sandwich". These attacks are serious, but have not, and we believe will not result in massive deportations or repression. In fact, probably the most serious attack on immigrants in practice since September 11th has not come from the Department of

tion program got a push from the promising meetings between Presidents Fox and Bush. Despite September 11th, both political parties have been discussing the need for some type of legalization law. The Democrats said that soon they will announce a concrete proposal. The underlying political factors (changes in voter demographics) and economic dependence on immigrant labor in many sectors of the economy will keep legalization on the legislative burner for some time into the future. It is critical that individuals as well as organizations in unions, churches and schools continue.



#### THE WELCH REPORT

#### ON ATTACKING IRAQ.

I am deeply troubled by President Bush's stated intention of "going after" terrorists in a number of different countries in an unending war.

Although there is no evidence to my knowledge that Iraq participated in the crimes of 9/11, it is that country which the Bush administration plans to attack, with the goal of removing its "bad guy" leader, Saddam Hussein. His weapons of mass destruction, undoubtedly, are a legitimate concern. (The invasion of Iraq reportedly has been postponed until 2003, delayed by events in the Israeli/Palestinian conflict.) I believe, however, that we have no moral or legal right to remove the elected leader of another country, even though he may be "evil".

The Iraqi people may well not revolt if we attack Saddam, as it is hoped they will do, given our history following the Gulf War.

It is anticipated that a ground attack against Saddam will require 200,000 or more troops. Casualties probably will be heavy, especially civilian, which will provoke more Arab and Muslim outrage.

Afterward we will be faced with the difficult task of establishing a new government for Iraq, requiring a substantial commitment of US resources and expertise. This Bush war against Iraq very probably will bring the world, including the US, <u>more</u> terrorism.

**ACTION:** We can inform our elected leaders in Washington of our strong objections to this expansion of the war into Iraq.

#### DECEPTIVE NUCLEAR TREATY.

A nuclear arms reduction treaty, the Strategic Offensive Reductions Treaty (SORT), was signed in May 2002 by Presidents Bush and Putin, calling for a reduction in strategic warheads to 1700-2200 on each side. The treaty does not require the destruction of any of the weapons, only their storage. Each country can take up to 10 years (until Dec. 31, 2012) before doing any actual weapons elimination.

Either country can withdraw from the treaty for any reason on three months notice. Remaining weapons are not taken off hair-trigger alert. The treaty still allows each country a massive overkill capacity (only a few hundred weapons are considered sufficient to protect either nation). (Source: Because People Matter July/August 2002)

Physicians for Social Responsibility recommends the following for strengthening the SORT Treaty:

- dismantle (destroy), not simply store, nuclear warheads (explosive part of weapon) –stored warheads, especially in Russia, are vulnerable to terrorist theft or purchase;
- improve verification and transparency measures (remember "Trust but verify"!);
- 3. accelerate and increase reductions in warheads (a timetable is needed); and
- 4. expand cooperative threat reduction programs (long-term action): e.g., the US Senate should work more diligently to expand financial and technical support to Russia for securing their nuclear weapons and nuclear material stockpiles.

Our Senate is expected to ratify SORT this fall, but it still is possible to add conditions to the Treaty (as the above, and others) that would greatly improve it.

#### **Legislative Action:**

Our congressmen are home this month. A good opportunity to contact them at their local offices and lobby for your priorities either by arranging a meeting with them, attending meetings where they will be speaking, or leaving messages for them. There is the issue of health care and prescription drugs that congress has yet to act on--the situation in Israel/Palestine with the U.S. Refusing to deal with Arafat while supporting Sharon's hard line positions, our huge investment in national missile defense program, dangers to our civil liberties as a result of our ongoing war on terrorism both at home and abroad.

But most urgent at this time is a need to speak out against going to war in Iraq. Please contact congressmen and senators about this even if you have already done so. Here is a statement by Phyllis Bennis of the Institute for Policy Studies. Although she was not called to testify before the Foreign Relations Committee, Senator Wellstone had her remarks read into the record. "Nelson Mandela was right when he said that attacking Iraq would be "a disaster." A U.S. invasion of Iraq would risk the lives of U.S. Military personnel and inevitably kill thousands of Iraqi civilians; it is not surprising that many U.S. military officers, including some within the Joint Chiefs of Staff, are publicly opposed to a new war against Iraq. Such an attack would violate international law and the UN Charter, and isolate us from our friends and allies around the world. An invasion would prevent the future return of UN arms inspectors, and will cost billions of dollars urgently needed at home. And at the end of the day, an invasion will not insure stability, let alone democracy, in Iraq or the rest of the volatile Middle East region, and will put American civilians at greater risk of hatred and perhaps terrorist attacks than they are today."

Joan Poss of Fresno will be a delegate to the World Summit on Sustainable Development (WSSD), sponsored by the United Nations, to be held August 26th to September 4th, 2002, in Johannesburg, South Africa. Poss's trip is sponsored by the Women's International League for Peace and Freedom (WILPF), the Fresno Center for Nonviolence (FCNV) and the Tehipite Chapter of the Sierra Club. "I have always been an environmentalist and a pacifist," says Ms. Poss, a 37-year charter member of the local WILPF organization. "I really understand the world," Poss says.
