On Saturday, 04/27/24, I worked uniformed patrol in the Central Policing District as 2A12. At approximately hours, I responded to the area of E Floradora Ave and N Linden Ave for a disturbance.

DV DIST, MA IS BLEEDING FROM THE MOUTH FEMALE FOLLOWING HIM, HE IS HM, BLK HAT, BLK SHIRT, SHE IS HF, BLK YOKA PANTS, RP HU BEFORE FURTHER

The following is a summary of the investigation, activities during that investigation, and the back-and-forth interviewing that occurred. It is not inclusive of everything that was said and done but includes the information that appeared relevant to me in the order and detail as I recall it, with statements related in chronological order relative to the topic, not necessarily in the order it was related to me nor exact quotes unless otherwise noted. Refer to Body Cam videos for specific and/or detailed statements.

### Investigation:

On arrival, I contacted Officer Cooper, who informed me to transport witness (W) \_\_\_\_\_ and gather his statement. After speaking with W-Garza, I provided him with the in-field admonishment. I gathered the following statement.

### Summarized statement of

W- \_\_\_\_\_ stated he resides in Kingsburg but came to Fresno, CA, to participate in the "Porch Fest." W- \_\_\_\_\_ was in the area of Floradora and Linden with friends and family when he observed an argument between a male and a few females. He stated it appeared the male began the argument by exchanging words and throwing a drink in a female's face; this led to the same female opening a bottle of water and squirting it in his face.

The male then grabbed the female by the upper arm area, and both parties exchanged about two or three punches with closed fists. W- \_\_\_\_\_ along with others, intervened and separated all involved parties. As the male suspect left the area, he walked southbound on Linden Ave, yelling, "You fucking Mexicans."

## Narrative by Araiza, Angel (continued)

During the in-field showup, W- said he recognized the male by his black hat, black shirt, and tan pants. W- mentioned the suspect male had, at one point, dragged a female across the grass. He did not wish to provide any further statement as he wanted to return to his family.

### Investigation Continued:

Upon returning to the scene, W- was sent on his way, and I was requested to conduct an additional in-field showup with the victim (V), Amelia Martinez. I transported V-Martinez from Floradora Ave and Linden Ave to the suspect's location. After advising her of the in-field admonishment, V-Martinez positively identified the male suspect by his black hat, black shirt, and cut on his mouth where he had been bleeding. V-Martinez did wish to pursue charges.

### Conclusions/Deductions:

On Saturday, 04/27/24, I assisted Officer Hull with his primary investigation. On arrival, I conducted two in-field showups with W- and V-Martinez, who identified the male suspect positively. V-Martinez did wish to pursue charges against the male suspect. I gathered a brief statement from W- who informed me he witnessed the altercation. W stated that the male started the whole argument and became physical first. Refer to Officer Hull's report for further.

On Saturday April 27, 2024 I was working uniformed patrol in the Central Policing District while assigned to 2F23 as a double unit with Ofc. J. Hernandez. At approximately 1618 hours, I was dispatched to N Echo Ave and E Hedges Ave to relieve day shift. I arrived at approximately 1627 hours.

### Investigation:

Upon arrival, we relieved Ofc. N. Quisenberry who was standing by with the Suspect - Francisco Samaniego. I observed Francisco to have scratches on his neck and arms which he advised were from the incident. Ofc. J. Hernandez took Francisco into custody by placing him in handcuffs, then conducted a search incident to arrest before placing him in the back of our patrol vehicle. We transported Francisco to CSIB for processing. While at CSIB, CSIB Tech H. Cano responded and took photographs of the injuries Francisco sustained during the incident. We then transported Francisco to FCJ where he was booked on all charges.

## Narrative by Hernandez, Roberto

### Source:

On 04/27/2024 at approximately 1554 hours, I was assigned to the Central Policing District as 2D12 and working in full uniform patrol in a fully marked patrol car. I was dispatched to N Echo Ave & E Hedges Ave, in the City and County of Fresno to assist Officers with a robbery.

The following is a summary of the investigation, activities during that investigation, and the back-and-forth interviewing that occurred. It is not inclusive of everything that was said and done but includes the information that appeared relevant to me in the order and detail as I recall it, with statements related in chronological order relative to the topic, not necessarily in the order it was related to me nor exact quotes unless otherwise noted. Refer to Body Cam videos for specific and/or detailed statements.

### Investigation:

I arrived at approximately 1556 hours and contacted Officer C. Cooper P827. Officer Cooper tasked me with taking a witness to a possible suspect to conduct an in-field identification. I then met with an adult woman who verbally identified herself as Witness- [redacted] I gave [redacted] the following admonishment...

*"You will be viewing a person who has been detained by the police. The fact that this person has been detained does not mean that he/she is actually the suspect involved in this crime. It is very important that you keep this in mind. The person may or may not be wearing the clothing you described previously. If this is the suspect, do not be afraid to tell me that. If it is not the suspect or you cannot be certain this is the suspect it is very important that you also tell me that. I do not want you to feel pressured in any way to identify someone."*

[redacted] stated she understood the admonishment by saying yes. I then transported [redacted] to N Echo and E Hedges Ave where Officer N. Quisenberry P1924 had the possible suspect detained. [redacted] was seated in the back of my patrol car and the possible suspect was standing approximately twenty feet away from the front of my patrol car. [redacted] had an unobstructed view of the possible suspect and stated "Yes, that's him." I asked what he had done and she told me he had assaulted someone. I later found out that this male was positively identified as Arrested- [redacted] I then transported [redacted] back to the original location of the call for service and proceeded to obtain her witness statement.

### Statement of Witness- [redacted] :

Weldon was attending Tower District's "Porch Fest" and was in front of an informational booth at 1394 N Linden Ave. Weldon noticed that the male she had identified, [redacted] was causing a disturbance. He appeared to be under the influence of alcohol as he was being loud and yelling at people. He was told by the owners of the booth to leave because he was being unruly but he refused. [redacted] was told to leave again after about ten minutes by a female. She said, "It's time to leave."

responded by throwing a drink at the female. The female then threw her water bottle at him. pulled her down by the hair and hit her. A different female tried to intercede and also began to get assaulted. There are now two girls fighting . A third female interceded with a "Taser" and sparked it warning to leave and to stop. did not stop so she sparked it three more times. finally left walking S/B on Echo Ave while destroying more property after the female with the taser said she would use it if he did not let go.

did not know any of the female's identity and had never seen the male before.

Officer Cooper tasked me with transporting a victim to a possible suspect to conduct an in-field identification. I then met with an adult woman who verbally identified herself as Victim-Zahra Alsafwani. I gave Alsafwani the following admonishment...

It is very important that you keep this in mind. The person may or may not be wearing the clothing you described previously. If this is the suspect, do not be afraid to tell me that. If it is not the suspect or you cannot be certain this is the suspect it is very important that you also tell me that. I do not want you to feel pressured in any way to identify someone."*

Alsafwani stated she understood the admonishment by saying "Yes Sir." I then transported Alsafwani to N Echo and E Hedges Ave where Officer N. Quisenberry P1924 had the possible suspect detained. Alsafwani was seated in the back of my patrol car and the possible suspect was standing approximately six feet away from the right side of my patrol car. Alsafwani had an unobstructed view of the possible suspect and confirmed he was the suspect. I asked what she recognized about him, and she said his hat. Alsafwani was "One hundred percent certain" it was him. I later found out that this male was positively identified as Arrested- I then transported Alsafwani back to the original location of the call for service. Please refer to Officer Cooper's report for more information regarding Alsafwani's statement.

On 04/27/2024, I assisted Officers in conducting a robbery investigation by conducting two in-field identifications and obtaining a witness statement.

On April 27, 2024, I worked in full-uniformed patrol in the Central Policing District as 2B11. At approx. 1546 hours, I was dispatched to N Echo Ave & E Hedges Ave regarding a possible disturbance involving a female following a male.

The call read as follows:

"DV DIST, MA IS BLEEDING FROM THE MOUTH FEMALE FOLLOWING HIM, HE IS HM, BLK HAT, BLK SHIRT, SHE IS HF, BLK YOKA PANTS, RP HU BEFORE FURTHER"

**Note:** The following narrative is a summary of the investigation, activities during the investigation, and the back-and-forth interviewing that occurred. It is not inclusive of everything said and done but includes the information appearing relevant to me in the order and detail as I recall it, with statements related in chronological order relative to the topic, not necessarily in the order it was related to me nor exact quotes unless otherwise noted. This investigation was recorded on my Axon camera. For exact statements, refer to Axon camera footage. This is a summary of the recording.

**Investigation:**

Upon arrival at approx. 1549 hours, I observed a male being followed by a female. Assisting Officer S. Ramirez and Corporal A. Lopez arrived moments before me and separated them. Officer Ramirez contacted the male, and I contacted the female, who was later identified as Lauren Lopez.

As I obtained information from V-Lopez, I determined that this call was related to 2B12's call at 1392 N Linden Ave (2404270794).

**Victim Witness (Lauren Lopez):**

Some friends and V-Lopez had a booth to support Palestine and provide educational information regarding the issues in Palestine for the Porch Fest. V-Lopez had walked around to other booths and was walking back to the booth at the southeast corner of Linden & Floradora. As V-Lopez walked back, she saw her friend, Zahra, talking to a male. She approached them, and Zahra told V-Lopez to help her with the male, who was being belligerent and appeared drunk. V-Lopez spoke with the male for about one to two minutes. During this time, he was telling V-Lopez that if they support Palestine, they support the Hamas and the terrorists. He continued to act belligerent with them. V-Lopez stated her friend Amelia showed up during the conversation and asked what was happening. The male then got more upset and began yelling at Amelia. Amelia told the male he needed to leave, or they would call the police. At this point, Amelia told V-Lopez to call the police. The male then threw a drink at the females and grabbed Amelia by the hair. V-Lopez got in between them to separate them.

V-Lopez stated the male then tried to peel her hand off of him, and in doing so, her cell phone fell out of her hand and fell to the ground. The male swung his fists and hit the females. V-Lopez stated he hit her twice with a closed fist. Once on the left shoulder and once on the back. The male then grabbed V-Lopez's keffiyeh (head scarf) and pulled it off her head. V-Lopez tried to reach for it and pull it from the male but was unable to do so. The male took off with her keffiyeh and her cell phone. V-Lopez followed the male southbound on Linden. V-Lopez asked the male to return her belongings. The male threw her keffiyeh on some bush as they continued to walk. She does not know where it landed or where it was at. V-Lopez asked for her cell phone, and the male told her, "Here you go," and threw the phone to the ground. The cellphone's screen was completely shattered, and V-Lopez could not use it to call the police. The male hid behind some bushes at the northeast corner of Echo & Hedges. At this point, V-Lopez asked people passing by to call the police for her. The male got out of the bushes, and V-Lopez followed him; moments later, officers arrived on the scene.

V-Lopez disclosed to me that the male said, "Fuck Palestine." He called V-Lopez a "stupid Palestinian bitch." He made other comments regarding Palestine and the females supporting Palestine, as already mentioned previously in this report.

**Investigation Continued:**

V-Lopez identified the detained male as the person who assaulted her and her friends and took her cell phone and keffiyeh.

The call stated a male took a cell phone and hit a female at this location. The male took off in an unknown direction. My Axon camera was on for this event the following is a summary of actions and statements taken.

### Investigation:

I arrived at the location. I found a block festival going on with a lot of people on foot and riding bikes. I was flagged down at the corner and told a female was just assaulted. She was sitting in a green car which would be on Floradora Ave. I parked my patrol vehicle and walked over to the car. I contacted Victim Confidential who is 22 years of age. I found her sitting in the driver seat of her vehicle. I asked her if she could tell me what had happened. She started off by saying her glasses were broken by an unknown male. She only had the lenses. She held them up and showed me. She did not know where the frames to her glasses were. She has a hard time seeing without her glasses.

I asked her if she could tell me what had taken place. Victim 22 years had just arrived at the house on the southeast corner of Linden and Floradora Ave. She was delivering papers to a booth. She saw her friend and an unknown male in a verbal disturbance. The male threw water on her and grabbed her by the hair. He pulled her to the ground. Victim 22 showed me grass stains on her jeans. Victim 22 said the male held on to her hair as he was pulling her on the ground. Someone came and helped her. They took the male off her. The Male took off running in an unknown direction. I asked if she needed medical attention. She told me no. I asked her if she knew where her frames are. She told me no. She lost her glasses during the fight and does not know what happened to them. She only has the glass that someone found for her and brought them back. She estimated her glasses cost about \$500 to replace.

Victim 22 also has bruises to her arm and left knee. She stated were caused by the unknown male who had attacked her. I asked if she had hit the male. Victim 22 told me when she arrived at the table to deliver the papers table the male was upset and yelling at her friends over the Israel and Palestine. He was yelling Hamas is terrorist and they should be killed. She was trying to deescalate the incident with the man yelling but out of nowhere he threw his glass of water on her. He turned and started to walk towards the street which would bend Floradora Ave. Victim 22 was mad and threw her bottle of water on him. He turned grabbed her by the hair and knocked her to the ground. He pulled her around the grass. Victim 22 said he was also yelling about killing Hamas. He yelled something about Mexicans should have no rights in this country. Victim 22 showed me a picture on her cell phone of her glasses. I used the Axon app on my department phone and took a series of photographs which will show the glasses that were destroyed.

I asked Victim 22 if she could describe the male me to. She described him as possibly a white male 30 to 40 years of age. Wearing a white shirt. He had on sunglasses and unknown type of pants. I asked if she could identify him if she saw him again. She could. Ref to the follow up report on Victim 22 completing an infield Show up and the identification of a Suspect 1.

I contacted confidential victim 33 at the location. I asked her if she could tell me what had happened or what did she see. Victim 33 was at a booth at the corner of Linden and Floradora Ave. She has a booth with Palestine flags hanging from it. She is educating people about Palestine. A male walked up and asked for a cookie. She gave one to him. The male asked for a glass of water which she gave to him. She started to talk to him and asked him if he needed anything further. The male started to argue and yell at her. He told her she was lucky she was in this country because if she was back in Palestine, Hamas would kill her. They would kill everybody like her because they are a terrorist group. Victim 33 told me she was 100% in fear of the male. He was yelling she should be murdered. Hamas and other people like them are terrorist and should be killed. Victim 33 was wearing a Palestinian Keffiyeh around her neck. It is red and white in color. I asked victim 33 if the male had said anything about this. She said yes it triggered him and he was saying people wearing those should be killed.

At this point her friend Victim 22 came up to the booth with papers. She started to engage the male Suspect. She watched as he became angry with her friend. He threw water on her and started to swing at her. Victim 33 said during this time. The male suspect was throwing punches at herself and friends. They are also females. She was struck in the chin by the male suspect as he was fighting with everybody. Victim 33 pulled out a Taser she has on her in a front zipper of her Fanny pack. She started to yell at the male, she had a Taser. Victim 33 also activated the TASER causing it to spark. She showed it to the male. I asked if she touched the male with her taser. She told me no. The male started to wrestle with victim 22 on the ground. She saw him reach out grab the glasses off the face of victim 22 and take off running. She gave her cell phone to another friend who chased after the male Suspect. I asked victim 33 if anything was taken from her during the fight. She told me no. She was just punched one time to the chin. Please refer to a follow-up report regarding victim 33 doing an infield show up with identification of the suspect.

On 4/27/24 at 1549 hrs I was assigned to patrol as 2F12 in CE district. I was dispatched to the area of N. Echo Ave and E. Hedges Ave for a call for service regarding a disturbance.

Note: The following narrative is a summary of the investigation, activities during the investigation, and the back and forth interviewing that occurred. It is not inclusive of everything said and done, but includes the information appearing relevant to me in the order and detail as I recall it, with statements related in chronological order relative to the topic, not necessarily in the order it was related to me nor exact quotes unless otherwise noted. This investigation was recorded on my Axon camera. For exact statements refer to Axon camera footage. This is a summary of the recording.

### Investigation:

Upon my arrival, assisting officers had located multiple involved parties in the area of N. Echo Ave and E. Hedges Ave. Upon initial contact, Officers contacted V-Lauren Lopez. While at the scene, she pointed to a man officer's were contacting across the street approximately 20 yards away and told me that man was the man who had assaulted her, forcefully removed her cultural head covering (Keffiyeh) and took her phone from her following a disturbance at a neighborhood event (Porchfest) where the man had verbalized a bias and disdain for the people there who were supportive of Palestine and Hamas. I observed Lopez to have "Free Hamas" and a Palestinian flag face painted on her cheek. Lopez's statement was obtained by Officer Ramos, see supplemental report for a detailed statement.

I then spoke with officers who had contacted Arr- presented with bloodshot, watery eyes, and a strong odor of an alcoholic beverage emitting from his person and appeared to be under the influence of an alcoholic beverage. had told officers that he was involved in an altercation with 3 females and clarified that he did not know them, but denied being the aggressor in the conflict. declined being seen by EMS, and his injuries included minor lacerations and bruising to the face, which were later documented through photographs by CSIB.

I then responded to the location of occurrence, and contacted officers who were working to locate witnesses and other victims. Officer Cooper assisted me by obtaining the statements of V-Zahra Alsafwani and V-Amelia Martinez. For complete statements, see Officer Cooper's supplemental report.

### INCIDENT SUMMARY:

All victims stated that approached their canopy area where there were multiple Palestinian flags displayed, and began engaging the females with foul language, calling them terrorist supporters, baby killers, and saying that they should be glad to not be in Palestine or they would be killed because females do not have rights in Palestine.

threw a cup of water, which hit one of the females, and a physical altercation ensued involving all three Victims and [redacted]. During the altercation, Alsafwani attempted to spark a stun gun to get [redacted] to stop, but he did not stop. [redacted] grabbed Martinez by the hair, grabbed her black framed glasses off of her face, and dragged her to the ground by her hair. Lopez attempted to intervene in the defense of Martinez, and [redacted] forcefully ripped the cultural head covering (Keffiyeh) Lopez was wearing off of her. [redacted] grabbed Lopez's phone from her hand.

After the parties were separated, [redacted] began fleeing the scene on foot, and discarded Lopez's Keffiyeh in a bush along his route of travel. Lopez was unable to locate the Keffiyeh at the time of my investigation. After walking approximately 3 houses away from the initial incident location, [redacted] threw Lopez's phone on the ground, causing the screen to shatter and the phone stopped working. [redacted] was followed by Lopez to the location where officers made contact with him.

### Investigation Continued:

Multiple officer contacted several witnesses in the area and obtained statements. Additional officers canvassed the area for video which captured the incident. See supplemental reports for additional information.

All three Victims were admonished regarding eyewitness identification and then separately transported to the location where [redacted] was contacted. All three victims positively identified [redacted] to officers during separate in-field show ups.

Sgt. Galaviz responded to the scene and spoke with all 3 victims.

CSIB was contacted and responded to the scene for injury photos of Martinez, which included bruising and redness in the left knee, both elbows and both forearms. Martinez also had a large grass stain on her pant leg which indicated she had been thrown to the ground and dragged while on the grass.

All victims were provided with case information, a Marsy's law form and a hate crime information brochure.

### Conclusions/Deductions:

On 4/27/24 at 1549 hrs I was dispatched to the area of N. Echo Ave and E. Hedges Ave for a call for service regarding a disturbance. Officers contacted three confidential Victims and obtained statements, and contacted additional witnesses in the area. After obtaining all statements, I determined that Arr [redacted] approached the victims at a neighborhood event because they were openly displaying pro-Palestinian symbols which included Palestinian flags and clothing, and began verbalizing anti-Palestinian beliefs. A physical altercation then ensued where Samaniego struck all three victims. During the altercation, [redacted] forcefully removed the cell phone and cultural head covering of V-Lopez, grabbed Martinez's glasses off her face, and began to flee the area. Lopez followed Samaniego as he left on foot. [redacted] threw Lopez's cell phone to the ground causing the screen to be damaged and the phone to stop working.

Due to the physical assault which had occurred on all three victims, I determined [redacted] was in violation of PC 242. Due to the forceful removal of Lopez's head covering and phone, and Martinez's glasses from her face, I determined [redacted] was in violation of PC 211. Due to Samaniego throwing Lopez's phone to the ground, causing it to be damaged, I determined [redacted] was in violation of PC 594(A)(2). Due to [redacted] actions being primarily motivated towards a bias against Palestine due to his words demonstrating that he was drawn to the location because of the open display of pro-Palestinian symbols, I determined Samaniego to be in violation of PC 422.6(A). [redacted] was arrested and transported to CSIB for fingerprinting, and booked into FCJ.

I then photographed a confidential adult female victim #1 injuries. Photos will show she had bruising and swelling under her chin.

Photos of a confidential adult female victim #2 injuries will show she had grass stains on her left pant leg. There was redness on her left knee, on her outer upper right arm, and on her left elbow. On her right elbow she had black stains. There was bruising on her outer right forearm.

I was then requested to go to the Crime Scene Investigation booking area. I took overall stand up photos of the suspect

Photos of \_\_\_\_\_ will show he was wearing a black shirt, khaki pants, and black and gray socks. Injuries photos will show he had scratches on the right side of his upper and lower lips, on his right collar bone area, on the inside of his left elbow, and on his left cheek. There was bruising below his left eye. I photographed the tops and bottoms of both of his hands due to the suspect having pain.

It should be noted per Officer Hull the case number 2404270794 was changed over to a new case number 2404270801. A new photo with the correct case number was uploaded.
